June 19-22, 2025

The Pre-Convention meeting of the Department Finance Commission was held at 10:00 am, Thursday, June 19, 2025, in Prairie AB rooms at the Huron Event Center, followed by the meeting of the Department Executive Committee, also in the Prairie AB rooms, at 1:00pm

The Convention Resolutions Committee's met at 10:00am, Friday, June 20, 2025, in the Board Room of the Huron Event Center. All Convention Committee Chairs met with Commander Morello and Adjutant Van Delist for an instructional meeting, information and supplies for their respective meetings. Convention Committee meetings took place at 1:30 pm in rooms throughout the Events Center. The South Dakota American Legion Foundation originally scheduled to meet at 3:00 pm but met earlier at 10:30am to better accommodate.

A joint Convention American Legion Memorial Service was held in Dakota CDGH at 4:30pm. Following the Joint Memorial Service, Senator John Thune addressed those in attendance.

At 7:00pm, Friday, June 20, 2025, in Prairie ABC The Joint Banquet took place with The American Legion National Commander, James A. LaCoursiere, Jr., Department of Connecticut, as guest speaker.

Department Commander Kevin Morello of Blackhawk, SD, (Piedmont Post 311) called the 106th Annual Convention of The American Legion Department of South Dakota to order at 9:00am, Saturday, June 21st, 2025, after a mini concert by the State American Legion Band.

The Color Guard advanced and posted the colors, The National Anthem was played, and the commander led all in the Pledge of Allegiance. Department Chaplain Mike Kumm gave the invocation followed by the POW/MIA ceremony by Department Adjutant C.P. Van Delist. Commander Morello led the delegates in reciting the Preamble to the Constitution of The American Legion. The Call for Convention was read by Adjutant Van Delist.

OFFICIAL CALL FOR CONVENTION OF
THE AMERICAN LEGION DEPARTMENT OF SOUTH DAKOTA

The ONE-HUNDRED-SIXTH ANNUAL CONVENTION of The American Legion Department of South Dakota is hereby called, and will be held in Huron, South Dakota, June 19-22, 2025.

PURPOSE

The Convention is called to elect officers for the ensuing year and delegates to the 106th National Convention of The American Legion, to consider any proposed

amendments to the Constitution and to transact such other business as may be brought before it.

REPRESENTATION

Representation at the convention will be by Posts. In accordance with the provisions of the Constitution, each Post is entitled to two delegates and two alternates plus one additional delegate and alternate for each fifty or major fraction thereof, memberships shown on the books of the State Adjutant fifteen days prior to the convention, or this year on June 4th, 2025. The Constitution requires that the delegates to the Department Convention be chosen by each Post by election from its own membership. Alternates will have power to vote only in the absence of the regular delegates.

Forms for listing the Department Convention Delegates and Alternates are sent to Post Adjutants. These forms need to be signed by the officers of the Post and mailed to reach State Headquarters, PO Box 67, Watertown, SD 57201 by June 4th, or turned in at the Department Convention Registration desk in Huron. Note that the 2025 membership identification number of each Delegate and Alternate is required.

In accordance with the Department of South Dakota Constitution and Bylaws, Article IX, Section 3: Every Legionnaire attending the Department Convention shall register and pay a registration fee of \$1.00 and upon proper identification as a Legionnaire in good standing shall receive a Convention badge and be entitled to the privileges of the Convention. The Legion Post hosting the Department Convention shall retain this \$1.00 fee to help defray expenses incurred in holding the Convention. The registration fee for each Post's delegate strength, regardless of attendance, shall be \$7.00 per delegate payable to The American Legion Department of South Dakota, in advance of the election at the annual Department Convention. Department Headquarters shall retain \$2.00 of each delegate registration fee and forward the remaining \$5.00 to the Department Convention host Post to help defray Convention costs.

DEPARTMENT EXECUTIVE COMMITTEE

A pre-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Huron Event Center, Huron, Thursday, June 19th, 2025, at 1:00 p.m.

A post-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Huron Event Center, immediately following the adjournment of the 106th Annual Department Convention of The American Legion Department of South Dakota.

POST/DISTRICT OFFICIALS

Post and District Officials, unless elected as Delegates or Alternates to the Department Convention, have no privileges in the Convention except as guests of their respective Posts and Districts.

CAUCUSES

Area Caucuses, for selection of State Vice Commander nominees, will be held in assigned areas, Saturday afternoon, June 21st, 2025, immediately following completion of that day's convention business session.

CONVENTION COMMITTEES

In accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, convention committees are to be convened for the purpose of compiling policy forming reports to the General Session of the Convention.

Each District shall designate Delegates or Alternates for service on each convention committee and shall file with the Department Adjutant a list of such designees at least two weeks prior to the convening date of the meetings of said convention committees.

The convention committees consist of the following:

Rules — 1 Delegate per District

The Department Commander will appoint Legionnaires, with membership in good standing, as the Chairperson and Liaison to each of the convention committees.

All convention committees will meet on Friday, June 20th, 2025, at 1:30 p.m. at the Huron Event Center, Huron, SD, in rooms designated for that purpose. The directory of meeting rooms will be available upon entry into the Huron Event Center, on the day of the meetings, and also in the Convention Program Book.

The Convention Resolutions Committee will hold its initial meeting, for the purpose of reviewing all convention resolutions to determine the distribution of said resolutions to the other convention committees, on Friday, June 20th, 2025, at 10:00 a.m., in the Huron Event Center, Huron, SD. Room assignments will be announced in the Convention Program Book and will be posted in the convention facility.

Each convention committee chairperson will be responsible for compiling a final report of the actions of their respective committees to the Department Adjutant after their committee has adjourned and prior to the scheduled report of the convention committee to the convention body.

RESOLUTIONS

Resolutions emanating from a Post shall be forwarded to the Department Adjutant to be in his hands no less than two days prior to the opening session of the Department Convention.

Resolutions which call for an amendment to the Constitution of The American Legion Department of South Dakota must be submitted to the Department Adjutant in the proper form by May 5th, 2025. This will ensure that the Department Internal Affairs Commission can screen them in time to allow for the commission's recommendations for approval or disapproval and for the Department Adjutant to distribute copies of these resolutions to all Posts within the Department at least 30 days prior to the convening of the Department Convention.

ELECTIONS

The election of all Department Officers as well as Delegates and Alternates to the 106th National Convention of The American Legion, shall be a Special Order of Business of the Convention and in accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, will be conducted at 12 O'clock noon on Sunday, June 22nd, 2025, or at the conclusion of all other business of the Department Convention, whichever occurs first.

Commander Morello introduced Mark Robish, Mayor of Huron who welcomed & brought. He additionally pointed out activities of interest in the community. Convention host, Post 7 Commander, Howard Alter, delivered his greetings and welcomed the assembled delegates to Huron.

State Vice Commander for Districts 3-8, Kevin Hempel, responded to the welcomes and thanked Huron for their hospitality as well as the Huron Post for all the hard work that went into hosting the Convention.

Commander Morello introduced Department of South Dakota Disabled American Veterans Commander, Tim Walsh, to deliver greetings. Commander Walsh commented on how our programs are second to none and thanked all of the Legion Family for their service to our Nation and communities. He shared a bit about the DAV Transportation Program and their service officers, who, like the American Legion's, assist Veterans in getting the benefits they have earned.

The Chair recognized the South Dakota State Council President of the Vietnam Veterans of America, David Gates, who brought greetings and thanked the American Legion for their work. He informed that in two years, the VVA will reorganize into the VVA Legacy Society so that the VVA will continue into perpetuity.

Jeremiah Schneider, Secretary of the South Dakota Department of Veterans Affairs (SDDVA), addressed the assembly. He thanked the Auxiliary for doing all they do. Secretary stated his goal for the SDDVA is to bridge the gap between the Veteran, State, and Federal entities and reconnect with Veterans. He also mentioned how priceless our programs are and encouraged to keep moving forward with them. He then introduced Aaron Pollard, who gave further updates on the SDDVA.

Department Commander Morello called on Andy Lyngen of Garretson (Garretson Post 23), Chair of the Convention Credentials Committee, to provide the Credentials Committee initial report. Chair Lyngen presented that report to the Convention.

Department Commander Morello then recognized Warren Aas, Watertown, SD, (Sisseton Post 50), Department Chair of the Veterans' Affairs and Rehabilitation Commission and also Chair of the Convention Rehabilitation Committee for the purpose of giving those reports.

CONVENTION REHABILITATION COMMITTEE REPORT

The Convention Rehabilitation Committee meeting was called to order by Chair Warren Aas of Watertown, at 1:30 p.m., Friday, June 20, 2025, in the Dakota D Room in the Crossroads Convention Center, Huron, SD.

Chair Aas led the Pledge of Allegiance and read the duties of the Convention Rehabilitation Committee on page 17 of the Uniform Code of Procedures. Chris Rendon of Summerset was appointed as secretary. The Convention Rehabilitation Committee was assigned no resolutions.

Our committee had a very interesting and productive discussion reference head-mounted virtual reality headsets to assist veterans dealing with issues such as PTSD, pain management, and can be programmed to fit the needs of the veterans. During the 2025 American Legion Washington Conference in Washington D.C., the VA Training and Engagement Executive Director of the Strategic Initiative Lab, Dr. Anne Lord Bailey, gave an excellent briefing on Immersive Technology and the use of the virtual headset. She indicated that at least one of these headsets is currently located in every VA Medical Center for use. Our committee had a great discussion reference this is an area that our department should pursue with our National VA&R Division in Washington, and hopefully someday these virtual headsets will become available to all veterans that in need of this help.

There being no further business to come before the committee, the convention committee rendered a hand salute to our flag. Ron Falor of Kimball made a motion to adjourn our meeting, seconded by Rodney “Buck” DeWeese of Spearfish. The Veterans Affairs and Rehabilitation Convention Committee meeting was declared adjourned at 1:55 p.m.

CONVENTION RULES COMMITTEE REPORT

The meeting of the Convention Rules Committee was called to order by Chair Kevin Hempel, Chester Post 136 at 1:30 pm, Friday June 20, 2025, at the Huron Convention Center in Huron SD. Chair Hempel led the participants in a salute to the colors and the Pledge of Allegiance.

In addition to Chair Hempel, the following were present: District 1 – Mike Pauling of Piedmont; District 2 – Matt Wendland of Hot Springs; District 3 – Larry Eliason of Pierre; District 4 – Aaron Grant of Groton; District 5 – Harry Boner of Castlewood; District 6 – Ken Andeson of Chamberlain; District 7 – Kevin Hempel; District 8 – was absent. Aaron Grant was assigned as Liaison for the committee.

Chair Hempel read Section 10 of the Duties of the Convention Rules Committee from the Uniform Code of Procedures for the Organization of The American Legion Department of South Dakota to the committee members and asked for any questions.

There were no resolutions assigned to the Rules committee; however, the committee reviewed the current Uniform Code of Procedures for the Organization of The American Legion Department of South Dakota for any updates or corrections. A motion made by Larry Eliason of Pierre, seconded by Ken Anderson of Chamberlain, with unanimous approval, the committee has two recommended changes.

First, under “Officials of the Convention” on page 3, the second line has “He” that should have been removed after the last update that should be removed from the next update to the booklet.

Second, on page 5, under the section of Duties of Convention Committees”, section 8 currently reads “**Rehabilitation** To formulate and recommend to the convention policies in all phases of veterans affairs as the concern veterans of World War I, World War II, the Korean and Vietnam Wars, and the Wars in Southwest Asia.....” The wording should be changed to “**Rehabilitation** To formulate and recommend to the Convention, policies of concern to all veterans....”

With no other items of business to discuss, Chair Hempel led the committee in a salute to the colors. A motion was made and seconded to recess subject to recall if needed. The meeting was recessed at 1:52 pm.

Chair Booze then announced the 2025 Department Oratorical Champion, Elena Andrews of Beresford, SD. Ms. Andrews also placed third at the National Oratory Competition in Hillsdale, MI. Over her three years of participation, Elena earned more than \$30,000 in scholarships. Elena addressed the assembly with highlights

from her year. She thanked the Legion for giving opportunities to young people and for the scholarships she won through the Oratorical contest. Last she stated one-third of her college is now paid for from her participation in American Legion Programs.

Commander Morello recognized Boys State Director, Gene Opbroek, Spearfish Post 164, to provide the Annual Boys State Report. The report was adopted. Director Opbroek then introduced the 2025 American Legion Boys State Governor, Brody Tynan, of Sioux Falls to address the Convention. He spoke on his experience at Boys State saying that Boys State was not only educational but also transformational. He also thanked the Legionnaires for providing a program that allowed him to find himself and regain the confidence that he had lost.

Chair of the Education Committee, Mike Pauling of Piedmont Post 311, was introduced by Commander Morello to deliver the Education Committee Report which was adopted.

The Chair recognized PDC/NEC Fred Nelson, Spearfish Post 164, American Legion Riders Liaison, to give that group's annual report. PDC Nelson gave a detailed report of the Ride 605 and thanked everyone who helped, from preparing food to the incredible generosity of donations, report was adopted.

The Chair recognized PNVC/PDC Byron Callies, Watertown Post 17, Chair of the Convention Internal Organization Committee and Chair of the Department Internal Affairs Commission to give those reports. Chair Callies explained the difference between the Convention Internal Organization Committee and the Internal Affairs Commission. Then gave the following report for the committee which was adopted. Chair Callies moved for the adoption of the report of the Convention Internal Organization Committee; the motion was duly seconded and carried. Department Commander Morello declared the Convention Internal Organization Committee Report adopted.

In the absence of Chair Lyle Tolsma Athletic Commission, Rapid City Post 22 Commander Morello asked Adjutant Van Delist to read the Commission’s Annual Report. The report was adopted. Additionally, Marv Tidsall, Box Elder Post 315, announced the South Dakota High School Activities Association voted down sanctioning High School baseball. This had been a hot topic for the last few years due to possible adverse effects on American Legion Baseball.

Commander Morello announced the Convention body would recess for lunch and delegates should return to the Convention Hall by 12:45 for the afternoon session.

Commander Morello reconvened the Convention at 12:52 with introducing Governor Larry Rhoden for comments to the assembled delegates. Governor Rhoden shared a story of an undeveloped roll of film from his father’s time in the Army during the Battle of the Bulge, that included pictures of a the Mauthausen Concentration Camp. He stated, some of the men in those pictures never made it home but they helped restore freedom. He drew connection between that and his recent trip to Israel, where people were sharing stories of family members who were prisoners at Mauthausen.

Commander Morello asked Scouting Chair, Chris Rendon, Rapid City Post 320, to give the Annual report of that Committee. The report was adopted. Rendon introduced Eagle Scout of the Year, Slater Humbracht from Troop 17, sponsored by Post 164 Spearfish for his comments.

Department Commander Morello called Department Chaplain, Mike Kumm of Sioux City, IA, (North Sioux City Post 319), for an award presentation. Chaplain Kumm and Commander Morello presented the South Dakota American Legion Good Samaritan Award to Sue Christiansen of Garretson while Adjutant Van Delist read her nomination submission.

Commander Morello recognized Andy Lyngen, Chair of the Convention Credentials Committee, for the final Credentials report.

Commander, Kevin Morello announced the time had arrived for the election of delegates and alternate delegates to the 106th Annual National American Legion Convention in Tampa, Florida. District Delegates and Alternate Delegates were nominated at the Spring District Meetings held in March and April. Adjutant Van Delist read the nominations for delegate, nominated during those spring district meetings.

ELECTION OF DELEGATES AND ALTERNATE DELEGATES

Adjutant Van Delist announced that South Dakota is entitled to five at-large Delegates and 15 others for a total of 21 Delegates. The Commander, Adjutant, Immediate Past Department Commander and National Executive Committeeman are automatic at-large Delegates. At Spring District Meetings seven delegates were nominated. There was no selection from District 8.

Department Adjutant Van Delist announced that there were seventeen unfilled Alternate Delegate slots. The following Legionnaires were elected as Alternate Delegates to the 106th Annual National Convention of The American Legion in Tampa, Florida during spring district meetings: District 1 – PDC Phil Anderson of Piedmont, District 2 – Chris Rendon of Rapid City Post 320, District 3 – Greg Smith of Gregory, District 4 - Vern Prickett of Stratford, District 5 – PDC Tim Jurgens of Milbank, District 6 - PDC Hugh Holmes of Mitchell, and District 7 - Dale Hill of Sioux Falls Post 15. There was no selection from District 8.

The following Legionnaires were selected as National Call-Ins and automatic delegates: PDC Paul Evenson of Garretson, Warren Aas of Sisseton Post 50, PDC Terry Hanson of Arlington, PDC Jim Huls of Salem Post 140, PDC Doug Feltman of Chamberlain, Kevin Hempel of Chester Post 136, Doug Harris of Rapid City Post 22, PDC Hugh Holmes of Madison, PDC Tim Jurgens of Milbank, and Brian Dean of Spearfish. Other automatic delegates included PDC and NEC Fred Nelson of Spearfish, Immediate Past Department Commander Kevin Morello of Piedmont Post 311, Department Commander Kevin Hemple of Chester Post 136, and Department Adjutant Van Delist of Rapid City 22

Delegates Brian Dean (District 1) and PDC Feltman (District 6) moved into call-in spots. District 1 Alternate Delegate Phil Anderson was moved to Delegate. District 6 Alternate Delegate, Hugh Holmes, also moved into a call-in spot, which meant that two total delegates could be selected from the Convention floor. Andy Lyngen of Garretson and PDC Charemon Dunham of Iroquois were nominated from the floor to fill the two Delegate vacancies.

The following were nominations for Alternate Delegates to the National Convention from the convention floor: Annette Dunham of Iroquois, Carol Howitz of Spearfish, Mike Kumm of North Sioux City Post 319, Dave Durfee of Redfield, and Sandy Smith of Gregory.

Adjutant Van Delist asked for a motion to approve both Delegates and Alternate Delegates that have been nominated to attend National Convention with one voice vote. It was moved, seconded, and voted to approve the Delegates and Alternate Delegates as presented.

Commander Morello asked for a motion to permit the Adjutant, with the approval of the Commander, to add individuals who contact Headquarters requesting to be an Alternate Delegate at a later date seeing as there are several Alternate Delegates spots left open. The request was so moved, seconded, and approved.

Department Commander Morello opened nominations for Department Sergeant-at-Arms for 2025-2026.

Subsequent calls for further nominations were unanswered. A motion was made to close the nominations and that a unanimous ballot be cast for Greg Geiman of Scotland, SD, for 2025-2026 Department Sergeant-at-Arms for The American Legion Department of South Dakota. The motion carried.

Adjutant Van Delist announced that Marvin Tisdall of Box Elder Post 315 was elected during the District 1, 2, and 3 caucus as their Vice Commander and that Shane Lamer of Montrose Post 154 was elected during the caucus of Districts 4-8 as their new Vice Commander. Their nominations were duly motioned and approved by the convention body.

Commander Kevin Morello opened nominations for the office of Department Commander of The American Legion, Department of South Dakota.

Kevin Hempel of Watertown (Chester Post 136) was nominated for Department Commander by David Booze of Piedmont Post 311 and seconded by Andy Lyngen of Garretson Post 23.

Bill Peters of Sioux Falls Post 15 was nominated for Department Commander by Al Arndt of Sioux Falls Post 15 and seconded by PDC Terry Hanson of Arlington, SD.

Subsequent calls for further nominations were unanswered, and nominations closed. Adjutant Van Delist called the roll for voting by the delegates. Following the completion of the vote tabulation, Commander Kevin Morello announced Hempel was elected as the Department Commander of The American Legion Department of South Dakota for 2025-2026.

Bill Peters then gave concessions and congratulatory remarks to the body. He gave heartfelt congratulations to Commander Hempel committing to be his membership chair for a third year and encouraged all to work together.

Newly elected Commander Hempel provided acceptance remarks. He thanked his wife of 50 years, Robin and all that contributed to his run for Commander. He highlighted many of the great things Legionnaires are doing around the state pushing his message of L.I.S.T.

This report is written to satisfy the Constitution and By Laws requirement for the Department Adjutant to write and present to the annual convention, a report covering activities not covered in the annual reports of the Committee and Commission Chairs and other Department officials. This report is as of May 8, 2025.

As I wrap up my second year as Adjutant, I am proud to report that since July 1st, 2024, I have visited 46 Posts, with over 90 separate Legion Events in total, attended 16 district meetings/conventions, attended eight Department Executive Committee Meetings, attended the Oratorical Contest, executed the Mid-Winter Conference (which thanks to Post 3 and PDC/ANEC Doug Feltman it was a great success.) Attended more than 43 meetings with outside organizations and spent 25 days conducting National Level meetings and activities; in total, I have spent over 75 nights on the road. All this and the year is not over yet. It has been a busy and rewarding year.



Past Department Commander Barns once said, "I think that The Department Adjutant of SD's office is an office that is hard to fill and suit everybody, because you are going to have fault to find with it wherever you are or whatever you do." He said that at the tenth annual Convention of the Department in 1928, and how true he was. I am honored and humbled to be able to work for the department and our members. I have done my best for what I feel is in the best interest of The American Legion.

With diminishing membership, another significant challenge has been finances. Our raw number of members is down, but our market penetration is the highest in the nation. More than 28% of the Veterans in South Dakota are members of The American Legion, this is something for the entire Department to be proud of. With the lower member numbers, our revenue is diminishing. At Department Headquarters, we have been striving to make as many cuts as possible. Continue to move as much as feasible away from mailing hard copies, and we eliminated a Department vehicle. We made changes to our annual meeting schedules to reduce travel and expenses and have conducted more meetings through video teleconference. Some of these changes have been met with apprehension but are necessary for health growth of the department. Finances will continue to be a significant challenge until we can stop depending on Membership dues as our main source of income. We must secure partnerships, sponsorships, and outside donors. If we continue to put the burden on the Posts to fund the department at some point, we will price ourselves out of membership.

This year has not been all challenges; there have been many rewards. Due to the hard work of Membership Chair Bill Peters and the Posts themselves, our department won the Big Twelve Challenge for our category for a second year in a row. That means \$2000 for investing in technology.

We continue to make changes and updates to the Department Headquarters. In the past year we have put on display our 106 years of history. Organized and cleaned out our digital systems to be more functional. We made the switch over to QuickBooks from our outdated antiquated bookkeeping system, and although it is not complete, we are working with our accountant to reconcile. We have overhauled the Department website and have new web hosting services. We dropped redundant email services and application subscriptions. We started using more applications we already have, including AI to build efficiencies in the office. The projects are not complete; we will continue to improve our home in the Codington County War Memorial and Courthouse building where we have been since 1928.

The headquarters staff consists of Mrs. Judy Greenfield, our Membership and Bookkeeper, who has been with the Department for 32 years, Mrs. MaryJo Boner, Executive Assistant and Programs Coordinator, who has been with the Department for seven years, and myself, the Department Adjutant, I will complete my second year in June. Judy and MaryJo are truly the backbone of the Department, without their dedication, our organization would come to a grinding halt. I am sincerely grateful to have these wonderful ladies to work alongside, they have made for a very welcoming first year.

Mister Commander, since most of the Committee Chairs and State Officers have filed complete reports, most of the activities of the Department have been covered and reported on. I would like to congratulate you on a very successful year.


It has truly been a privilege to have you as my Commander; you have left some big shoes for your successors to fill.

NATIONAL EXECUTIVE COMMITTEEMAN REPORT

Department Commander Morello and fellow Legionnaires,

I am honored to submit this annual report as the South Dakota National Executive Committeeman (NEC), reflecting our department's engagement and representation at the national level of The American Legion over the past year.



National Convention – New Orleans - The 105th National Convention in New Orleans brought together over 6,500 delegates, alternates, and guests. South Dakota was well represented by a dedicated delegation. We actively participated in committee meetings during the convention, engaged with resolutions affecting national policy, and maintained a visible presence on the convention floor.

One convention highlight was the keynote address from Lt. Gen. Russel Honoré, USA (Ret.), who commanded Joint Task Force Katrina. His message on leadership, resilience, and responsibility profoundly impacted attendees.

The convention concluded with the election of **James A. LaCoursiere Jr.** as our new National Commander. His theme, **L.U.V. – Loyalty, Unity, and Valor**, reinforces the foundational principles of our organization. His leadership calls for strengthening veteran suicide prevention efforts through the **“Be the One”** initiative, increasing visibility in our communities, and expanding legislative advocacy.

NEC Duties and Committee Involvement - As your NEC, I participated in the National Executive Committee's post-convention meeting and the Fall NEC Meeting, where critical decisions regarding policy, finance, and program direction were made. I worked to ensure South Dakota's values and concerns were presented during deliberations.

I also attended the 2025 **American Legion Washington Conference**, where I had the honor of witnessing **National Commander LaCoursiere** testify before Congress. His powerful testimony reinforced our national priorities and elevated the voice of veterans on Capitol Hill. His commitment to veteran suicide prevention, expanded caregiver support, and protection of earned benefits was well-received and critical to our continued advocacy efforts.

I will continue to represent South Dakota at the upcoming **Spring NEC Meeting**, where we will again deliberate on key organizational priorities, policy development, and resolutions impacting veterans and their families nationwide.

Legislative Advocacy - National Commander LaCoursiere emphasized the need to bolster our legislative efforts. This includes support for key initiatives such as:

- **The GI Bill Parity Act**, to support our National Guard and Reserve;
- **The Major Richard Star Act**, to allow concurrent receipt of VA disability and DOD retirement;
- **Funding protection for the Coast Guard** during government shutdowns.

South Dakota's voice is vital in these national conversations. I urge all posts to remain engaged with our Congressional delegation and participate in grassroots advocacy to reinforce these priorities.

Looking Ahead - As we move forward, I challenge every Legionnaire to embrace our mission with renewed energy:

- Continue growing the “Be the One” campaign through post-level programs and partnerships.

- Promote our visibility through service projects, public events, and media engagement.

- Encourage membership growth by emphasizing our impact and purpose.

Let us stand united in our efforts, upholding the ideals of Loyalty, Unity, and Valor.



DEPARTMENT FINANCE REPORT

Commander Morello,

As Department Finance Officer and Chair of the Finance Commission, it has been an honor to serve the Legionnaires of the Department of South Dakota. It has been a pleasure to serve alongside the other members of the Finance Commission who are PDC Paul Evenson, David Booze, Dave Gutzmer, and Dale Hill. These individuals continue to be key in monitoring and advising on budget issues, and in helping me in my role as Department Finance Officer.



The Finance Commission met in July 2024 to prepare a budget for the Fiscal Year 2024-2025 which was then presented to the Department Executive Committee for their approval. The DEC approved a 2024-2025 budget of \$324,575.59. This amount was based on known expenditures such as salaries, insurance, office expenditures and program costs. In addition, Commissions, Committees, and programs had additional requests that were used to determine a budget total.

As of March 31, 2025, income for the Department from membership has been \$206,535.29 (64% of budgeted). Outside income from SD Fundraising Account (\$31,265.59), USAA Royalty Payment from National (\$4,011), AGIA (\$38,310.53), Emblem Royalty (\$3,517.78), SD American Legion Foundation (\$16,590), and MidWinter Sweeps (\$16,426.51) which totaled \$110,121.80. Additional income will come from 2025 Convention Sweeps. Total income to date is \$316,656.70 which is 97.6% of budgeted.

As of March 31, 2025, Department expenditures total \$193,038.91 (59.5% of projected budget) with a remaining budget of \$131,536.68. The chances are good for not exceeding our income this year. The Cash Balance Report at the beginning of the year had a Cash Balance of \$1,124,974.79 and at the end of March the Cash Balance Report indicated a balance of \$1,166,566.24. It should be noted that that amount includes the Edward Jones Account (formally listed as Trust Fund Account) which has gone from \$846,070.44 to \$940,566.01.

A more detailed report will be in the Proceedings from this Convention once the financials have been reviewed by an outside agency. The Financials of the Department of South Dakota have remained viable and stable over this past Fiscal Year.

AMERICANISM COMMISSION REPORT

Commander Morello,

Thanks for the opportunity to have served as the South Dakota American Legion's 2024-2025 Americanism Chair. As of this report's submission, to meet the 1 May 2025 suspense date of the "Big Three Americanism Programs:" Boys State, Youth Trooper Academy, and the Department's Scholarship Oratorical Program, only the Oratory Program has been completed.



I extend my thanks to the past Americanism Officers: Dan Wyatt, Harry Boner, Doug Harris, and Larry Madsen, and to Past Department Commander Doug Feltman, plus committee members Larry Madsen, Clayton Nei, Mike Kraft, and Ken Sabers for their advice and expertise throughout my tenure as Americanism Officer. A special thanks to MaryJo Boner of Department Headquarters for her assistance in preparing and distribution of the annual Americanism Package along with my accompanying Americanism Officer's Letter to each of the District's and Post's Americanism Officers. In recognition that the American Legion is a family, MaryJo Boner also facilitated effective coordination and mutual support with the Auxiliary to incorporate the Auxiliary's Girls States Program and other related interests.

The Americanism 2024-2025 Program year kicked off the year with an Americanism Program Familiarization Presentation to the Department Executive Committee (DEC) and attending guests at the DEC's 13 July 2024 meeting held at Watertown American Legion Post 17.

In the 2024 fall, eligible students, grades 9 through 12 and under 20 years of age, enrolled in public, parochial, military, private, and state accredited home schooling, selected and prepared their oratory thesis based on the United States of America Constitution for Post level oratory competition. Following the Post contests, each District's Oratorical contests were concluded in January 2025. The Department Scholarship Oratorical Contest was held Sunday, 16 February 2025, at 10:30 AM CDT, at the Arrowood Resort and Conference Center in Oacoma, South Dakota at the conclusion of the Department's 2025 Mid-winter Conference.

Originally, seven Districts were scheduled to have contestants at the Department Oratorical Contest. Unfortunately, due to untimely personal and family hardships, two candidates were unable to attend. The five remaining Districts contestants each provided original highly polished, thoughtful, and stimulating prepared 8-to-10-minute presentations. Followed by an assigned constitutional amendment, each contestant demonstrated their in-depth knowledge of the assigned topic, plus an ability to organize their thoughts and discuss for 3 to 5 minutes, our government under the principles of the constitution as related to the assigned topic.

The winner of the Department Contest was Elna Andrews of District 7's Beresford American Legion Post 7. She received Department's \$1,500 Scholarship and 1st Place Trophy. Elna and an accompanying sponsor will travel expenses paid to the National Oratorical Competition being held, 16 to 18 May 2025, at Hillsdale College, Hillsdale, Michigan, with an opportunity to win \$25,000 for a 1st place

finish, \$22,500 for 2nd place, or \$20,000 for 3rd place, as well as \$2,000 for each round of participation at the National Competition.

Our second-place Department Contestant and recipient of \$1,000 Scholarship and trophy, was Blixa L. Broussard, sponsored by District 2's Rapid City American Legion Post 22. Placing 3rd and recipient of \$500 scholarship and a trophy was Ada Sharp, representing District 4's Aberdeen American Legion Post 24. Each of our finalists: Preston Singrey sponsored by District 6's Arlington American Legion Post 42, and Christian Carley representing District 1's Box Elder's American Legion Post 315, each received \$200 and a trophy.

I extend my personal thanks to the 22 volunteers from across the American Legion Family of Legionnaires, Auxiliary, SAL, and community citizens, who enabled the Department's 2025 Oratorical Contest to flow smoothly. A special thanks to Past Department Commander Doug Feltman for obtaining the five exceptional judges plus an alternate judge, whose task to evaluate and rank order the contestants and subsequent placings was no easy feat.

Prior to the Department's Mid-winter Conference, the Americanism Commission met via Teams on 30 January to review the progress status of Americanism programs. Of special note, historically Post and Individual Americanism Awards selections were processed by the commission on Blue Hat Day during Boys State Week. There was a need identified to break from history in order to avoid distracting volunteers from Boys State support requirements. It was decided to meet the week prior to Boys State on 29 May at Pierre's American Legion Post 8. After an informative Shooting Sports presentation by Americanism Commission member Mike Kraft, the Commission unanimously agreed to propose inclusion of Shooting Sports as an Americanism Program. Mike Kraft has agreed to chair the Americanism Shooting Sports Committee and to lead its implementation. Within my submission for the 2025-2026 Fiscal Year Americanism Budget, I have dedicated a section for a budget line to be added to Department's Annual Budget Planning process. It is anticipated the initial year funding will be handled with donations and dedicated fund-raising projects, minimizing impact to the upcoming 2025-2026 Fiscal Year Budget. Additional topics included Boys State registration status, Youth Trooper Academy, plus an update by Lyle Tolsma, Athletic Chair, on our 100th Year of American Legion Baseball, as well as the current state of High School Baseball Program development.

Due to initial low registration numbers, the Youth Trooper Academy registration was extended two (2) weeks to 4 April, as a result, registrations more than doubled to 55 individuals. Youth Trooper Academy interviews were concluded by 12 April, with quality male and female Academy cadets selected to fill the 24 Academy slots. The Youth Trooper Academy begins immediately following the Department's Annual Convention on Monday, 23 June, concluding on Friday, 27 June, with Blue Hat Day scheduled to be at the shooting range on Thursday, 26 June 2025. A special shout out and congratulations to our 2024 Youth Trooper Academy "Outstanding Graduate," and \$500.00 Scholarship winner, Bowan Ryan from Castlewood American Legion Post 250. Bowan is currently attending Lake Area Technical Institute studying Criminal Justice.

Boys State is scheduled for Monday, 2 June through Friday, 6 June 2025. Registration is currently lagging with registrations currently below last year's rate. This continuing downhill trend is reflective over the past few years. How to reverse

this decline for the upcoming 2025-2026 Program Year will be a topic to be addressed with the Boys State Director and his staff, as well as the Ad-hoc Strategic Planning Committee. This year's fee to be paid by each Post for each Boys State Attendee is \$250.00, plus their transportation costs. Blue Hat Day is scheduled for Thursday, 5 June. I encourage all to visit with Boys State participants and the activities orchestrated by the Program Staff to develop our future community, state, and national leaders.

Our support of the Scouting Program continues to engage in the development of our youth. Of the three applications received for Eagle Scout of the Year, the winner was from Spearfish Post 164. The Eagle Scout winner's project involved making an ADA-compliant accessible wheelchair ramp, with a movable railing to load and unload commodities in and out of the VFW building. This challenging project provides noteworthy service to the physically challenged and disabled individuals of the community.

Unfortunately, it is noted that some schools do not include the Americanism Programs in their curriculum of extracurricular opportunities for students to expand their civic and patriotic education beyond the basic classroom instruction. I encourage the American Legion Family Leadership to engage their school district boards and school administrators, plus teachers to increase participation in all our programs: Flag Education, Veterans in the Classroom, Oratory Scholarship, Boys State to include the Auxiliary's Girls State, Youth Trooper Academy, Athletic Program of Legion Baseball, Scouting Program, and Shooting Sports Program.

As each District and their Post prepares your Post annual Americanism program goals for the next program year, and your Annual Americanism Report for submission, reach out and contact your school officials this spring to schedule appointments involving your Post on the upcoming new school year calendar.

There will be American Legion Baseball teams from SD, ND, NE, and MN participating in the tournament. We welcome all who would like to join in on the celebration to come to Milbank, SD. The Annual Boys State Session will be held on the NSU Campus in Aberdeen SD on 2-6 June 2025.


We currently have paltry 128 registered attendees. The Annual Boys State Corporation meeting will be held on Sunday 1 June at 3pm on the campus of NSU.

CHILDREN AND YOUTH REPORT

Commander Morello,

The South Dakota American Legion Children and Youth (C&Y) program has kept me busy. I want to thank you for your leadership and willingness to help direct my efforts with the C&Y program this past year. I greatly appreciate it.

For the past several years, I have worked with the C&Y programs within the Department. I have had the opportunity to work with many great American Legion Family members from across the Department with fundraiser events in support of The Children's Miracle Network, Special Olympics, Holiday Meal gift card program for young service members and their families, plus I have been able to help organize and direct service-related activities on behalf of Operation Homefront.



The service activities that the Department supports at the beginning of every new Legion year are:

- The annual Backpack Distribution program is put on by the Family Readiness Department at Ellsworth Air Force Base near Rapid City the last weekend in July. Just this past July, we had 18 American Legion, Auxiliary, SAL, and Rider members from three Districts helping to hand out 400 donated backpacks filled with school supplies. These activities were reported in last fall's Up to Now, The Rising Son, and The Legionette newsletter, along with photos of the event. This event is expected to grow this coming July, and more assistance will be requested from the Department as time draws closer.

- The second service program that we assisted with was the annual Dollar Tree program, where volunteers were asked to pick up donated school supplies over the summer and donated toys in November. These were to be donated to National Guard Armories, VA facilities, or state organizations to assist our younger veteran families with some of the necessities needed for the school year. We had a great crew from the Aberdeen Post assist with this program where over 100 gift bags of donated items were distributed to the Aberdeen VA CBOC and to the local field office of Social Services.

- These are great programs that I hope the American Legion will continue to be a part of.

We had an early start to the 2024/2025 American Legion year by assisting a few veterans with children at home with filing of TFA (Temporary Financial Assistance) requests.

- The Sioux Falls Post Commander and Children and Youth program Chair did a fantastic job working with a veteran in their area which resulted in that veteran receiving the assistance that was requested.

- Our second veteran worked with the Clear Lake Post and myself for assistance and while a formal request for TFA was not submitted, that veteran was able to receive assistance from Operation Homefront which better suited their needs at the time.

- Most recently, I received a request through the Sioux Falls Post where a veteran grandparent needed assistance with taking care of their child and grandchildren. While there were grandchildren living with the veteran, the rules of how to obtain assistance through a TFA request are clear. The minor children in

need must belong to the veteran or if the older veteran has custody of the minor children, then TFA assistance may be possible. This was as a result of The American Legion passing Resolution No. 5 (May 2022) Titled: Policy and Procedures of the Temporary Financial Assistance Grant Program. The policy clearly states that the minor child must be living full-time in the home of a qualifying veteran or service member. The minor child qualifies if they fall into one of the following categories. Yes, the veteran (the grandparent) could qualify for TFA if the minor child(ren) is living in the veteran's home full-time and is under the veteran's legal guardianship or has been adopted by the veteran. Veterans can apply for assistance through their local American Legion Post if the child is:

- o a biological child of the veteran or service member,
- o a child legally adopted by the veteran or service member,
- o a stepchild by marriage of the veteran or service member, or
- o a child who is under the legal guardianship of a veteran or service member.

While it has been a busy year, not much of the available budget has been tapped into yet. With April being Children and Youth Month, there are programs and projects where the available funds will be used to assist the programs once the month is over. I have made this known to the Department leadership of our Legion family in the first week of April. I suggested at the time that unless some of the available funds were needed during the month of April, the balance of the funds would be split between programs supported by the leadership of each branch of the Legion Family within the Department, such as;

- Special Olympics and the Children's Miracle Network of South Dakota.

These programs are supported by The American Legion, Legion Riders, and the Sons of the American Legion,

- Project Stuff Sack, which is supported by The American Legion Auxiliary
- Operation Homefront programs that are supported by the entire Department Family.

The chart below reflects my current budget used to date. I have sent out an email to the Children and Youth Committee requesting their support for these programs. Of the remaining \$1,304.94 in the Program budget, each of these four programs listed above will receive a \$325 check in support of their work. I will use a portion of the Committee funds to help cover cost for C&Y awards and expenses during the convention. There are many Posts from across the Department that represented the C&Y programs over the past month that should be recognized.

EDUCATIONAL SCHOLARSHIP COMMITTEE REPORT

Department Commander Kevin Morello,

The past year, the Educational Scholarship fund received approximately \$4,144.65 in donations. The cost of some of these donations included the dissolution of Fulton Farmer Post 85 of Epiphany, South Dakota. As seen, in previous years donations to the Education Scholarship fund were zero, this past year's donations have a bittersweet taste. At present, the investing value of the South Dakota Community Fund account is last known at \$147,701.00. Monies not invested currently being held in a Savings Account was last known as \$20,275.03. I would recommend the Department Executive Committee explore the option of rebalancing the Savings Account more towards the Investment Account for succeeding years forthcoming. This recommendation is since 4% of the fund value is used to disburse scholarship award amounts to the successful applicants. More scholarship monies mean more disbursements.



Seven applications were received for this year's scholarships. Of the seven applicants, one was deemed ineligible on its face and another is under review for eligibility based on the relationship of the applicant to a connected member of the South Dakota American Legion family. The eligibility issue is whether the Legion Member is current in the present membership year. At last check, the member was expired. Resolution of this issue will be addressed prior to disbursement of monies from the Scholarship Fund. As of now, the Education Committee can disburse up to \$6,852.00 to the qualified recipients.

The 2024 State Educator the Year for South Dakota was Chad Long, who was also recognized as the American Legion National Educator of the Year 2024. Mr. Long is an Educator of the Lyman School District.

The Education Scholarships offered by the Department of South Dakota are for the children of Veterans, grandchildren of Veterans, and Veterans who met the requirements set forth in the Education Scholarship brochure, attending post-

secondary education, college or technical schools. The fund is self-sustaining through donations.

After serving on the Education Committee for several years, I will be submitting my proposed changes to the Education Scholarship Fund to the Department Executive Committee prior to State Convention. I am of the mind that the Education Scholarship Fund (now released of its previous Loan component) can be more effectively utilized as a recruitment, retention and revision of mission to better serve the South Dakota American Legion Family as a whole.

Mr. Commander, I will be stepping down as Chair after the State Convention so that I can focus my efforts on other pursuits. I will remain a sitting member of the State Education Committee (with the consent of your replacement) for my remaining obligation.

This letter serves as my annual report as Chair of the Employment Committee for the past year. A core tenet of The American Legion is ensuring the well-being of our veterans, and this extends directly to fostering opportunities for meaningful employment. Recognizing organizations that actively support our veterans through employment is crucial to this mission and benefits both the veterans and our communities here in South Dakota.



Our state is fortunate to have many employers who value the unique skills, training, leadership, work ethic, integrity, and discipline that veterans bring to the workforce. It is vital that we, as Legionnaires, identify and celebrate these employers who provide good-paying jobs, positive work environments, and comprehensive benefits to our fellow veterans.

Unfortunately, the Department did not receive any nominations for our employment awards last year. To ensure deserving organizations are recognized, I strongly encourage all posts to actively seek out and nominate eligible candidates in their local areas this year.

As a reminder, the Department offers the following employment awards, recognizing different aspects of veteran support:

Employer of Older Workers Award: Honors employers who demonstrate a commitment to hiring and retaining older workers, including veterans.

Homeless Veterans Outreach Award: Recognizes individuals or organizations making a significant impact in assisting homeless veterans.

Award to Enhance the Lives of Disabled Persons: Celebrates efforts to improve the quality of life and employment opportunities for individuals with disabilities, including veterans.

Employer of Veterans Awards (Small, Medium, and Large Employer): Acknowledges employers of varying sizes who demonstrate outstanding commitment to hiring and supporting veterans.

The Employment Service Award: Recognizes individuals or organizations providing exceptional employment services to veterans.

The deadline for submitting award nominations is November 15, 2025. Detailed information regarding the criteria and nomination process for each award can be found on the Employment Awards Forms page of the Department website: <https://sdlegion.org/employment-award-forms>



SOUTH DAKOTA AMERICAN LEGION FOUNDATION REPORT

The South Dakota American Legion Foundation began in 2010, because of the foresight of our leaders at the time, in believing that it is important to have a steady source of revenue to help support the valuable programs of the American Legion. It is structured as a 501(C)(3) non-profit corporation as designated by IRS, so that the donations to it can be tax deductible for the donor. The funds are professionally managed by the South Dakota Community Foundation. Donations to the Foundation go into an endowed fund that is invested and are not spendable. It is the return on these investments that becomes available to the SD American Legion to support the programs. In this way, the endowed fund itself is not depleted and will continue to grow. The returns on these investments will continue to come back to the Legion forever. As the endowed funds grow over time, so do the returns coming back to the Legion.



The Foundation has three accounts. A General Fund, with funds that come directly from donors; an Agency Fund, with funds that came to the Foundation in the form of cash or from credit cards, which is then forwarded to the endowed fund; and a Youth Law Enforcement Fund, designed to specifically assist with the Youth Trooper Program. As of this writing, the balance in all three accounts totals \$368,026.22. Volatility in the stock market impacts our funds, but over time, growth has been very positive.

The Foundation is working! In the last three years, \$41,720 has come back to the SD American Legion to support programs. Since inception, over \$90,600 has come back to the Legion to support programs of children and youth. At the present

time, \$13,814.04 is available to “Grant” back to support children and veteran programs.

Donations can be in many forms. Gifts of cash or property; bequests through estates, by naming the SD AL Foundation in your will; memorials in memory of friends and fellow veterans and Legion members who have passed; naming the SD AL Foundation as the beneficiary of a life insurance policy so it will pay out upon death; as an IRS approved “IRA Charitable Rollover Gift”, so that your distribution is paid directly to the Foundation rather than become taxable income to you. All of these gifts help assure that the American Legion programs that you care about will continue to be supported forever. Gifts of \$10,000 or more by an individual entitle the donor to name the specific Legion program that he/she wishes to support. Please let the Foundation know if you would like assistance in structuring a donation.

This past year the Foundation was honored to receive a gift of over \$11,000 in retirement funds left through the estate of deceased individual. We also received a very generous donation of \$10,000 from an individual to honor her Korean War Veteran and dedicated Legion member father, and her dedicated Legion Auxiliary member mother, and to honor “all” veterans. Thank you!

Thank you to all of the individuals, Legion Posts, veterans’ organizations and businesses who have made donations to the Foundation! Many Posts and individuals regularly give memorials to honor friends, fellow veterans and Legion members who have passed on, helping their legacy to continue. Thank you very much! Many Posts have made significant donations to the Foundation. Thank you very much! Your support of fundraisers such as the Fun Auction at the Department Conventions each year, and raffles held over the years help support your Foundation. Thank you!

The Foundation Board members serve staggered terms at the appointment of the Department Commander, with the approval of the Department Executive Committee. Thank you, Mr. Commander, for the privilege to serve!



INTERNAL AFFAIRS COMMISSION REPORT

Commander Morello,

Thank you for allowing me to be the Chair of the Internal Affairs Commission. The Internal Affairs Commission exists to give oversight to several areas of the American Legion in South Dakota. These include reviewing resolutions to amend the Constitution and By-Laws as well as any other resolutions. Also, the Commission has purview regarding the American Legion Riders and Sons of the American Legion. This year, the Commission met on May 8, 2025, and reviewed nine resolutions. After much discussion, these were acted on and, if needed, forwarded to the appropriate convention committee. Discussions included some minor verbiage changes to the Constitution, fundraising issues, Youth Shooting programs, dates of district meetings, Vice Commander changes in oversight, and corrections allowed without general membership consensus. A more detailed report will be given at Department Convention in June.



The Internal Affairs Commission was called to order by Chair Byron Callies on May 8, 2025, at 1000 hours. Tribute to the colors and Pledge of Allegiance was recited. A quorum was established by voice vote or telephone or video conference.

The Commission's duty is to review any resolutions affecting the Department Constitution and By-Law and to forward any other resolutions to the appropriate convention committee. Three resolutions were forwarded to the convention committee. The following resolutions were received and recommendations made.

25-01 Establish a South Dakota American Legion Youth Shooting Sports Program. Action taken to recommend approval as amended.

25-02 A resolution to establish a Department Fundraising Committee. Action was to reject this resolution.

25-03 A resolution to establish a minimum to two District meetings to be held. One being in the fall between September 1 and December 1 of each year. The second to be held between March 1 and May 1 of each year. This resolution also allows the Commander to call special District Meetings as deemed necessary. Action taken to recommend approval of the resolution.

25-04 A resolution to change the area command structure to Area 1, District 1, 2, and 3. Area 2, Districts 4, 5, 6, 7, and 8. The respective Commanders will be designated Western Vice Commander and Eastern Vice Commander. Action taken to recommend approval of the resolution.

25-05 A resolution to change minor wording errors in the current Department Constitution and By-Laws, Section 6, Commissions and Committees.

25-06 A resolution to express appreciation to Post 7 for an exceptional job of hosting the 2025 Department of South Dakota Annual Convention. This resolution was forwarded to the Convention Resolutions Committee.

25-07 A resolution to allow the Department Commander to hold office for one more year by re-election. This term must be consecutive. Action taken was to recommend rejection of this resolution.

25-08 A resolution that National Headquarters be timelier in returning to the Departments, monies that have been collected by annual dues. This resolution was forwarded to the Department Convention Resolutions Committee.

25-09 A resolution allowing the Department Adjutant to make minor corrections to the Constitution and By-Laws, provided that said changes do not alter the intent, meaning, or substance of the wording.

25-10 A resolution updating the ability of the Commander to direct the duties of the Vice-Commanders. Action taken was to recommend approval of the resolution.

25-11 A resolution to support the program America250 by encouraging the participation of local schools and civic organizations to commemorate 250 years independence of the USA. This resolution was forwarded to the Convention Resolutions Committee.


Since there was no other business germane to the Internal Affairs Commission, the Commission was adjourned.

LEGION RIDERS REPORT

Commander Morello and Fellow Legionnaires,
Serving as the Department Commander's Liaison for the American Legion Riders (ALR) during the 2024–2025 year has been an honor. The ALR program remains one of the American Legion's most visible and celebrated initiatives. Its ongoing success is a testament to the grassroots efforts of its post-level chapters, powered by the dedication of Legionnaires, Auxiliary members, and Sons of the American Legion.

The American Legion Riders continue to uphold the Four Pillars of the American Legion: **Veterans Affairs and Rehabilitation, National Security, Americanism, and Children and Youth.**



Veterans Affairs and Rehabilitation

Throughout the year, ALR chapters across South Dakota have honored fallen veterans with funeral escorts and flag lines. Unaccompanied veterans continue to receive dignified quarterly honors at Black Hills National Cemetery. Riders remain committed to supporting VA facilities through regular visits and coordinating morale-boosting events such as concerts, game nights, and social activities. Their presence is also strongly felt statewide during Veterans Day and Memorial Day ceremonies.

National Security

Riders continued their unwavering focus on POW/MIA awareness, promoting accountability and remembrance through ceremonies and educational outreach. Their support for deployed service members remains active with care package drives, escort

missions, and community engagement. One of the key recurring initiatives has been the successful coordination of community blood drives, emphasizing their dedication to both public health and military support.

Americanism

Promoting patriotism through education is a key ALR priority. During the 2024–2025 year, Riders reached hundreds of students across the state with flag etiquette presentations and school programs, instilling a sense of respect and national pride. Additionally, Riders conducted Veterans Day presentations and engaged with classrooms through ongoing youth outreach efforts.

Children and Youth

The ALR has made meaningful contributions to the welfare of children and families, particularly those impacted by military service. Activities include providing school supplies to children of deployed service members, supporting youth programs such as CASA, organizing holiday events, and donating essential items to transitional housing and community shelters. Riders also offered medical assistance to families in need and organized events focused on comforting hospitalized children and bringing joy to local youth.

Growth and Community

The ALR continues to grow in both membership and influence. Riders have a visible and inspiring presence at major events like the Sturgis Rally, where they lead high-profile rides supporting veterans' scholarships and participate in parades celebrating service and sacrifice. Their role in helping to escort Midwest Honor Flight participants remains a deeply valued tradition, reinforcing their commitment to honoring those who served.

ALR Statewide

Coordination among chapters is vital to the ALR's continued effectiveness. Department-level gatherings at the Midwinter Conference, the State Convention, and the annual SD-ALR Rendezvous provide key opportunities for collaboration and planning. In June 2025, Riders from across South Dakota will unite in the Black Hills for the ALR Rendezvous, an annual event that blends business with camaraderie. The gathering includes a wreath-laying ceremony at Black Hills National Cemetery and the state-wide meeting.

Department Support

A dedicated group of American Legion Riders will journey across South Dakota to collect donations June 7-10. All proceeds from the ride are donated to the South Dakota American Legion Foundation, which directly benefits veterans and youth programs throughout the state. Last year's ride raised approximately \$6,700 to support these vital initiatives.

Looking Ahead

With fifteen active ALR chapters throughout the state, South Dakota has a strong foundation, but the potential for growth remains. I encourage all Posts to consider the value an ALR chapter can bring to their American Legion Family. Together, we can continue to expand our reach, deepen our impact, and serve our communities and veterans with pride and purpose.

To all Riders across South Dakota, your dedication, patriotism, and service embody the spirit of the American Legion. Here's to another impactful and mission-driven year ahead.

LEGISLATIVE COMMITTEE CHAIR REPORT

Commander Morello,

I am Mike Mehlhaff, the Chair of the South Dakota American Legion Legislative Committee. First, I must recognize the team of Legionnaires that has helped with the legislative work of the Department: Commander Kevin Morello, Dan Fritz, Nathan Juelfs, Doug Feltman, Dan Heil, and Adjutant Van Delist. In a normal year we would not be as successful without this great team, but doubly so this year, and they have stepped up to represent the legislative interests of the Legion at every crucial moment and I ask you to please recognize them with a round of applause.



The Legislative Committee started our work on Monday, January 27th when we met at the American Legion Post 8 in Pierre. Pending Legislation was discussed, and the committee determined the best approach to several bills that affect veterans and the military. As new legislation has been brought forward, we have continued to confer and make decisions on the Legion will lobby and testify on those bills.

Here is an overview of the bills that the Legion Legislative Committee worked with this year: (refer to SD Legion Report)

Following our busy work on January 27th, we got to have a little fun by hosting the annual SD Legion Legislative Dinner. A crowd of nearly 100 people joined us for a meal of pulled pork sandwiches and discussed issues important to veterans and our country.

With 30 plus legislators in attendance the dinner was a great success. Legislators have so many choices of events to attend each night, and to have so many of them attend our dinner shows how respected the Legion and its members are when it comes to the legislature.

Putting together a dinner for 100 people is not something that you can do by yourself, and this dinner would not have been so successful without the hard work of the host city's Post. The members of Pierre Legion Post 8 were gracious and hardworking hosts who provided the facility and the manpower necessary to make this dinner the best it could be. I would especially like to recognize Post 8 members Larry Eliason and Ralph Bush for all their hard work and support in completing the mission of hosting a top-quality event.

House Bill 1160: waive the driver license renewal period for members of the military and their families, and employees of the state department.

Department Position: The Department monitored this legislation.

Final disposition: Signed by the Governor 02/25/2025

House Bill 1161: allow additional forms to verify military service for a veteran designation on a commercial driver license or commercial learner's permit.

Department Position: The Department supported this legislation.

Final disposition: Signed by the Governor 03/28/2025

House Bill 1162: require the reporting of the number of veterans who die by suicide in this state.

Department Position: The Department supported this legislation as it is in line with our Be the One Campaign.

Final disposition: Tabled by House Military and Veteran's Affairs 02/18/2025

House Bill 1163: make an appropriation for a grant to assist in the construction and equipping of a veteran's skilled trade center.

House Bill 1188: allow nonresident military members to purchase three-day temporary nonresident waterfowl licenses.

Department Position: The Department monitored this legislation.

Final disposition: Signed by the Governor 03/05/2025

Senate Concurrent Resolution 603: Supporting the establishment of a standardized system to recognize and award academic credit or certification for military service.

Department Position: The Department supported this resolution.

Final disposition: Passed as a resolution on 02/13/2025

Senate Concurrent Resolution 604: Supporting the expansion of transportation services for veterans receiving medical care in this state.

Department Position: The Department fully supported this legislation.

Final disposition: Passed as a resolution on 02/18/2025





PUBLIC SAFETY COMMITTEE REPORT

The South Dakota Public Safety Committee enjoyed another great year. After the State Legion Convention, Dianne Johnson, Doug Feltman and I had the privilege to attend the South Dakota Youth Trooper Academy. Our committee met again in January to select the winners of the “Law Enforcement Officer” of the Year; the “Firefighter of The Year”; and the “EMT” of the Year award winners.

South Dakota Youth Trooper Academy:



Again, this year, we selected 24 outstanding young men and women from South Dakota High Schools to attend the 12th SDYTA. For the first time, we graduated all 24 Recruits. The SDHP did an outstanding job of hosting the Academy at the Law Enforcement Training Center in Pierre. Ten State Troopers from across the State volunteer to be away from their Duty Stations, family, and friends, to come serve as instructors and Mentors. The logistic duties are taken care of by SGT Schoenefeld and Lt. Brandon Akron. These Troopers, somehow, squeeze these duties into their already very busy schedules.

This year, we had multiple Mentors working at the Academy who are former graduates of this outstanding program. It is very rewarding to see these young Troopers engaged in a very professional manner, as they all do.

Recruits experience a very rigorous week of activities. From learning how to march, engaging in vigorous Physical activities, to learning the basics of the duties of Law Enforcement Officers. They also spend many hours with hands-on activities such as stopping vehicles, drug interdiction, crash scene investigations, negotiating cars through the obstacle course on the Emergency Vehicle Operations Course and firing weapons on the pistol and rifle range.

On “Blue Cap” Day we had several Legion members and guests come to the Rifle Range to see the Recruits in action and to witness several demonstrations. Later in the evening, the American Legion hosted another BBQ, which is always a lot of fun for everyone.

The week is capped off by a very inspirational Graduation Ceremony at the Visitor Center near the reflection pond and the Memorials.

This year, the American Legion \$500 “Outstanding Graduate Scholarship” winner was Bowan Ryan from Castlewood. Ryan is attending Lake Area Technical College in Watertown. He is pursuing a career in Criminal Justice.

Your Public Safety Committee would like to thank everyone for your support for this outstanding program. Because of our efforts, many of our graduates have become Law Enforcement Officers and/or members of the Military. Others will gain a much better appreciation for Law Enforcement and what the American Legion is all about.

Your SDALPSC met in January to select the LEO, FF, and EMT of the year recipients. Again, we did not receive many applications for these awards. These recognitions are very important to those “First Responders” who work to keep our communities safe. The L.E.O. and the FF of the year are designated, officially, by the National American Legion.

As a Public Safety Committee, we encourage each post to consider recognizing these public servants. There are some small communities who may not have many living in your community to select from. However, first responders can come from anywhere in your area. Also, there are numerous Law Enforcement agencies as well as rural or city fire departments to consider. EMT’s also include Paramedics.

One issue we have had is the difficulty finding the proper documentation to support these applications. This next year, we are going to develop examples of proper documentation for our applications. The instructions for filling out these applications are on the State website. A reminder, it is not the responsibility of the supervisor of the nominee to fill out the application.

Once you have submitted an application, it will be much easier the next time. Feel free to call any member of our committee and we would be happy to assist you. NOTE: Please do not rely on the applicant or their supervisor to complete the application. That final packet should be done by the post.

This year’s recipients of these awards are: “Law Enforcement Officer of the Year” SGT. Micah Hoffman, a Deputy from the Lake County Sheriff’s Office, Madison: The “Firefighter of the Year” is Logan Arthurs, sponsored by the Redfield Post: and the “EMT of the Year” is Elizabeth Verhey from Spearfish. STRATEGIC PLANNING COMMITTEE REPORT

Commander Morello,

Thanks for the opportunity to serve as the South Dakota American Legion's Strategic Planning Committee Chair, along with distinguished Committee Members: PDC Doug Feltman, Larry Madsen, Bill Peters, and Matt Pillar. As of this report's submission, the newly established Ad-hoc Strategic Planning Committee met virtually via Microsoft Teams on Tuesday, 8 April 2025, to organize and develop a path forward to accomplish the initial guidance and assigned tasks:



(1) First, to conduct a review of "The National American Legion's Strategic Plan", and its "2019 Ad-hoc Committee Report" to identify National's Strategic Plan's requirements upon Department versus, Department's implementation of those requirements, and

(2) Second of equal strategic importance, develop the Department of South Dakota American Legion's Strategic Plan by assessing the Department's organization structure, functions, and relationships throughout the Department's organization and components to ensure continued relevancy of the American Legion based on its mission, vision, goals, and interrelationships.

The committee adopted an established formal "Five Step Strategic Planning Process" to guide its efforts. Step one starts with assessing current and future operating environment applying "Strengths, Weaknesses, Opportunities, and Threats" or SWOT as abbreviated. SWOT is a key component of throughout strategic planning, and next step two identifies goals and objectives, followed by

step three to developing the plan, then step four to communicate and implement the plan, and in step five monitor performance, and if necessary and as required, modify the strategic plan inclusive of organization structure, interrelationships, and functions, to sustain and enhance American Legion's relevancy-based mission, vision, values, and goals.

The committee recognizes that individuals and teams will be working various topic assignments and coordinating with subject matter experts throughout the Department's American Legion Family membership via telephone, virtual meetings, and full committee face-to-face meetings as required to maximize efforts toward the assigned purposes end state.

The committee initial "Face to Face Working Session" will have occurred the day before the start of Annual Department's Convention on Wednesday, 18 June 2025 at the Huron Crossroads Hotel & Convention Center in Huron, South Dakota.

Thank you, Commander Morello for this opportunity, and thank you to the Strategic Planning Committee members for their direction and support as we collectively continue this work to develop, produce, monitor the implementation performance, and modify an active and living Department of South Dakota American Legion Strategic Plan.

TRAINING COMMITTEE ANNUAL REPORT

Commander,

The Training Committee had a productive and impactful year, continuing to expand and improve our educational programs for Legionnaires across South Dakota. At the 2025 Mid-Winter Conference, our breakout training sessions were well attended and positively reviewed. Classes included "Reports and Awards," "Post Constitution & By-Laws," "Navigating the New Department and National Websites," "MyLegion App," and "Be The One." Feedback indicated that sessions were relevant, the instructors were well-prepared, and the material was useful. Some technical issues with connectivity were noted, and we plan to mitigate these in future events by bringing MiFi devices.



The highlight of the year was the Third Annual South Dakota American Legion College (SDALC), held April 26–27, 2025, at the Chamberlain Community Center. Instructional sessions included Mentorship, Running a Meeting, Resolution Writing, Train-the-Trainer, Organizational Structure, and the Capstone Project. Feedback was overwhelmingly positive. Students appreciated both the content and the networking opportunities, including the group dinner at Charlie's Restaurant.

Throughout the year, the committee worked closely to evaluate curriculum, manage logistics, and plan for future development. Notably, we are exploring the addition of classes focusing on the American Legion Family, as well as a potential online Adjutant training course. We also discussed succession planning and identified the need to recruit two new committee members and an instructor for Mid-Winter and SDALC 2026.

The Training Committee is committed to developing knowledgeable leaders who are prepared to support the mission of the American Legion throughout our state.

TRUST FUND COMMITTEE CHAIR REPORT

Commander,

January 2024 Value of Investment account: \$689,091. Asset allocation: 51% Equities (stocks) and 49% Fixed income (bonds).

September 2024 Jeff Merchant assumed duties as Committee Chair

Trust Fund Committee Meeting. Discussed the current asset allocation and concerns about the conservative 50/50 split. A traditional 60/40 split would enable growth while maintaining some downside protection. Voted to create an Investment Policy Statement (IPS) for the Department.



November 2024 Trust Fund Committee Meeting Competed draft of the Department's IPS. Recommendation to forward the proposed IPS to the Department Executive Committee for approval.

December 2024 Chair presented the IPS to the Department Executive Committee. Investment portfolio closed out the year at \$921,623 (10% growth).

February 2025 Chair attends Midwinter Conference and briefs Finance Committee on the proposed IPS. Department Executive Committee approves the proposed IPS.

May 2025 Total value of the Investment Portfolio is \$947,590. Asset allocation is 53% Equities and 47% Fixed Income (bonds). **Comments:** We have engaged with the financial advisory firm to increase our holdings in equities. As outlined in our IPS, we would like to maintain 60% equities and 40% in fixed income. The underpinnings of the US economy remain strong & the outlook for the remainder of the year remains positive, at least by most analysts. We want the portfolio well-positioned to take advantage of improving market conditions. That approved asset allocation remains in our best interests.



As a member of the National VA&R Commission, I had the privilege of attending the Washington Conference in February 2025 in Washington D.C. to listen and participate in the national VA&R Commission agenda. 

VETERAN'S COUNCIL REPORT

Commander Morello and Fellow Legionnaires,

It's been another busy and productive year on the South Dakota Veterans Council (SDVC), and I'm grateful for the opportunity to represent The American Legion as we continue working together to support veterans across our state.

Who We Are and What We Do: The SDVC brings together representatives from The American Legion (TAL), Disabled American Veterans (DAV), Veterans of Foreign Wars (VFW), Paralyzed Veterans of America (PVA), Vietnam Veterans of America (VVA), and the Military Order of the Purple Heart (MOPH). We meet throughout the year—in person and virtually keeping each other updated, sharing resources, and most importantly, ensuring veterans' voices are heard at all levels. This past year, we met in places like Pierre, Hot Springs, and Mitchell, which has made it easier for more people from across the state to participate.



Highlights and Progress

- **Legislative Work:** We monitored veteran-related bills like SB 52, HB 1010, HB 1038, and HB 1046. In January, we hosted a Legislative Mixer, where we had the chance to connect directly with lawmakers and advocate for better services and benefits for South Dakota veterans.
- **Endowment Update:** The Endowment Fund for the State Veterans Cemetery in Sioux Falls continues to grow. As of January, it held just over \$3.4

million, with nearly \$300,000 available to spend. That fund helps ensure the cemetery remains a place of honor and dignity for generations.

Facing Challenges

- **Staffing at Veterans Homes:** Like many places, our state veterans' home feels the pressure of workforce shortages. The Council supports partnering with colleges and the VA to train and retain good staff.
- **Timing and Visibility:** The Council voted to move officer elections from July to April to better align with the legislative calendar. This should help us stay ahead of key decisions and legislative deadlines.
- **Rural Outreach:** We're exploring new ways, especially online tools and local events, to better reach veterans in rural areas who might not have easy access to the services they need.

Looking Ahead; Next year, we'll stay focused on:

- **Mental health and long-term care**—ensuring those needing support get it.
- **Federal legislation**, including the GI Bill Parity Act and the Major Richard Star Act, and ensuring our Coast Guard members aren't left behind during budget talks.
- **Better coordination** across our member organizations so we can work smarter and speak with one voice.

Final Thoughts

It's truly been an honor to serve on the South Dakota Veterans Council and to represent The American Legion. We've made real progress this past year, and I'm confident that we'll keep moving forward for the benefit of all our veterans and their families.

WHEREAS, The American Legion has a long-standing tradition of supporting youth programs that promote citizenship, responsibility, and sportsmanship; and

WHEREAS, The addition of an American Legion Youth Shooting Sports Program in South Dakota would provide young individuals with the opportunity to learn firearm safety, marksmanship, and leadership while reinforcing core values of discipline and respect; and

WHEREAS, The primary objective of this program is to foster responsible firearm handling and marksmanship skills among youth while emphasizing safety, teamwork, and personal development; and **WHEREAS**, The program structure includes eligibility for youth ages 12-18, certified instructor-led safety courses, compliance with NRA, CMP, and USA Shooting safety regulations, and competitive opportunities at local, state, and national levels; and

WHEREAS, The program will collaborate with the South Dakota Shooting Sports Association, 4-H Shooting Sports, and other local organizations, as well as seek sponsorships from firearm safety organizations and sporting goods companies; and

WHEREAS, The program will provide the opportunity to collaborate through the Shooting Sports Program the opportunities the American Legion has with Boys State, Oratory Contest, Scouting Program and Youth Trooper Academy; and

WHEREAS, The program will be sustained through departmental and post-level fundraising, corporate and local sponsorships, grant opportunities, and participant fees; now, therefore, be it

RESOLVED, By The American Legion Department of South Dakota in Annual Department Convention assembled in Huron, South Dakota, June 19th – 22nd, 2025, that The American Legion, Department of South Dakota approves the establishment of the South Dakota American Legion Youth Shooting Sports Program; and, be it further

RESOLVED, That this resolution shall take effect immediately upon approval.

Internal Affairs Committee action: DO NOT PASS recommendation.

WHEREAS, The South Dakota American Legion aims to continually support veterans, their families, and the community at large through various programs and initiatives; and

WHEREAS, effective fundraising efforts are essential to sustain and enhance the mission and operations of the South Dakota American Legion; and

WHEREAS, the establishment of a dedicated committee focused on fundraising activities will streamline efforts, increase efficiency, and maximize the impact of fundraising initiatives; now, therefore, be it

RESOLVED, at The American Legion Department of South Dakota Department Convention assembled in Huron, South Dakota, June 19th – 22nd, 2025, That the following amendments be made to the Constitution and Bylaws of the South Dakota American Legion: Under, Article IV: ADMINISTRATION, Section 6: COMMISSION and COMMITTEE, Subsection c) Committees: Subpart a: Permanent Committees

Add, xi. Fundraising Committee; and, be it further

RESOLVED, The purpose of the Fundraising Committee shall be established to coordinate, plan, and execute fundraising activities in support of the objectives and programs of the South Dakota American Legion; and, be it further

RESOLVED, Membership of The Fundraising Committee shall consist of five (5) members, appointed by the Commander one from each of the Membership Committee, Finance Commission, Marketing Media and Communications Committee and two at-large members with approval of the Department Executive Committee; and, be it further

RESOLVED, The responsibilities shall be:

- a. Develop and implement fundraising strategies, campaigns, and events to generate financial support for The American Legion programs and initiatives,**
- b. Collaborate with Legion leadership, members, and community partners to identify fundraising opportunities and cultivate donor relationships,**
- c. Maintain accurate records of all fundraising activities, including donations received, and expenses incurred,**
- d. Provide regular reports on fundraising activities and financial status to the Department Executive Committee,**
- e. Ensure compliance with all relevant laws, regulations, and policies governing fundraising activities; and, be it further**

RESOLVED, The terms of the Committee members shall serve an annual term with the exception of the at-large members who shall serve a term of three (3) years, with the term of the at-large members expiring in separate years, with the option for reappointment at the discretion of the Commander and Department Executive Committee; and, be it further

b) The Spring District meetings shall be called by the Department Commander not earlier than March 1 nor later than May 1 each year, and the call for said district meeting shall be given by the Department Adjutant to the Posts of each district at least 15 days prior to such meeting. The intent of this meeting is to allow the District Commander and Department to conduct business as required.”

“Two Department Vice Commanders shall be elected at each Department Convention, one from Districts One, Two and Three and will be the Western Vice Commander, and one from Districts Four, Five, Six, Seven and Eight and will be the Eastern Vice Commander.”
