ONE-HUNDRED-SECOND ANNUAL CONVENTION

THE AMERICAN LEGION

Department of South Dakota June 24-27, 2021

The Pre-Convention meeting of the American Legion Department Finance Commission was held at 10:00 a.m., Thursday, June 24, 2021, in Salon II at the Huron Convention Center, Huron, South Dakota, followed by the meeting of the South Dakota American Legion Department Executive Committee in Prairie Rooms A and B of the same facility at 1:00 p.m.

The South Dakota American Legion Training Committee met at 3:30 p.m., Thursday, June 24, 2021, in the same room in the Huron Convention Center, Huron, SD.

The Convention Resolutions Committee's initial meeting was held at 10:00 a.m., Friday, June 25, 2021, in the Symposium Room in the Huron Convention Center, Huron, South Dakota. The meetings of the other Convention Committees were held at 1:30 p.m., Friday, June 25, 2021, in rooms so designated in the Convention Center. The American Legion/American Legion Auxiliary/Sons of The American Legion Joint Banquet was held at 7:00 p.m. on Friday, June 25, 2021, in Dakota Rooms C,D,G,and H, at the Huron Convention Center in Huron, South Dakota with James Troiola, 2nd Leading Candidate for National Commander as the guest speaker.

The 102nd Annual Convention of The American Legion Department of South Dakota was called to order at 9:00 a.m., Saturday, June 26th, 2021, in Huron Convention Center, Huron, South Dakota, by Department Commander Fred Nelson of Spearfish, SD, after a mini concert by the State American Legion Band.

The Colors were advanced and posted by the Color Guard. The National Anthem was played. Department Commander Fred Nelson led the delegates in the Pledge of Allegiance. Department Chaplain Justin Warfel offered the invocation after which Department Adjutant Kevin Hempel conducted the POW/MIA ceremony. Department Commander Nelson led the delegates in reciting the Preamble to the Constitution of The American Legion in unison.

The Call for Convention was read by Department Adjutant Kevin Hempel.

OFFICIAL CALL FOR THE ONE-HUNDRED-SECOND ANNUAL CONVENTION OF THE AMERICAN LEGION DEPARTMENT OF SOUTH DAKOTA

The ONE-HUNDRED-SECOND ANNUAL CONVENTION of The American Legion Department of South Dakota is hereby called, and in conformity with action taken at the Ninety-Seventh Convention, will be held in Huron, South Dakota, June 24, 25, 26, and 27, 2021.

PURPOSE

The Convention is called to elect officers for the ensuing year and delegates to the $102^{\rm nd}$ National Convention of The American Legion, to consider any proposed amendments to the Constitution and to transact such other business as may be brought before it.

REPRESENTATION

Representation at the convention will be by Posts. In accordance with the provisions of the Constitution, each Post is entitled to two delegates and two alternates plus one additional delegate and alternate for each fifty or major fraction thereof, memberships shown on the books of the State Adjutant fifteen days prior to the convention, or this year on June 9th, 2021. The Constitution requires that the delegates to the Department Convention be chosen by each Post by election from its own membership. Alternates will have power to vote only in the absence of the regular delegates.

Forms for listing the Department Convention Delegates and Alternates are sent to Post Adjutants. These forms need to be signed by the officers of the Post and mailed to reach State Headquarters, PO Box 67, Watertown, SD 57201 by June 24th, or turned in at the Department Convention Registration desk in Sioux Falls. Note that the 2021 membership identification number of each Delegate and Alternate is required.

In accordance with the Department of South Dakota Constitution and Bylaws, Article IX, Section 3: Every Legionnaire attending the Department Convention shall register and pay a registration fee of \$1.00 and upon proper identification as a Legionnaire in good standing shall receive a Convention badge and be entitled to the privileges of the Convention. The Legion Post hosting the Department Convention shall retain this \$1.00 fee to help defray expenses incurred in holding the Convention. The registration fee for each Post's delegate strength, regardless of attendance, shall be \$7.00 per delegate payable to The American Legion Department of South Dakota, in advance of the election at the annual Department Convention. Department Headquarters shall retain \$2.00 of each delegate registration fee and forward the remaining \$5.00 to the Department Convention host Post to help defray Convention costs.

DEPARTMENT EXECUTIVE COMMITTEE

A pre-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Huron Convention Center, Thursday, June 24, 2021, at 1:00 p.m.

A post-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Huron Convention Center, immediately following the adjournment of the 102nd Annual Department Convention of The American Legion Department of South Dakota.

POST/DISTRICT OFFICIALS

Post and District Officials, unless elected as Delegates or Alternates to the Department Convention, have no privileges in the Convention except as guests of their respective Posts and Districts.

CAUCUSES

Area Caucuses, for selection of State Vice Commander nominees, will be held in assigned areas, Saturday afternoon, June 26, 2021, immediately following completion of that day's convention business session.

CONVENTION COMMITTEES

In accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, convention committees are to be convened for the purpose of compiling policy forming reports to the General Session of the Convention.

Each District shall designate Delegates or Alternates for service on each convention committee and shall file with the Department Adjutant a list of such designees at least two weeks prior to the convening date of the meetings of said convention committees. The convention committees consist of the following:

The Department Commander will appoint Legionnaires, with membership in good standing, as the Chairperson and Liaison to each of the convention committees.

All convention committees will meet on Friday, June 25, 2021, at 1:30 p.m. at the

All convention committees will meet on Friday, June 25, 2021, at 1:30 p.m. at the Huron Convention Center, Sioux Falls, SD, in rooms designated for that purpose. The directory of meeting rooms will be available upon entry into the Huron

Convention Center on the day of the meetings and also in the Convention Program Book.

The Convention Resolutions Committee will hold its initial meeting, for the purpose of reviewing all convention resolutions to determine the distribution of said resolutions to the other convention committees, on Friday, June 25, 2021, at 10:00 a.m., in the Huron Convention Center, Huron, SD. Room assignments will be announced in the Convention Program Book and will be posted in the convention facility.

Each convention committee chairperson will be responsible for compiling a final report of the actions of their respective committee to the Department Adjutant after their committee has adjourned and prior to the scheduled report of the convention committee to the convention body.

RESOLUTIONS

Resolutions emanating from a Post shall be forwarded to the Department Adjutant to be in his hands no less than two days prior to the opening session of the Department Convention.

Resolutions which call for an amendment to the Constitution of The American Legion Department of South Dakota must be submitted to the Department Adjutant in the proper form by May 1, 2021. This will ensure that the Department Internal Affairs Commission can screen them in time to allow for the commission's recommendations for approval or disapproval and for the Department Adjutant to distribute copies of these resolutions to all Posts within the Department at least 30 days prior to the convening of the Department Convention.

ELECTIONS

The election of all Department Officers as well as Delegates and Alternates to the 102^{nd} National Convention of The American Legion, shall be a Special Order of Business of the Convention and in accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, will be conducted at 12 O'clock noon on Sunday, June 27, 2021, or at the conclusion of all other business of the Department Convention, whichever occurs first.

The assembly body gave a warm welcome to the Huron Mayor, Gary Harrington.

Convention host, Post #7 Commander Jake Salathe, delivered his greetings and welcomed the assembled delegates to Huron.

State Vice Commander for Districts 3-8, Harry Boner, responded to the welcome.

Commander Fred Nelson introduced the Honorable Dusty Johnson, South Dakota's Congressman to the United States House of Representatives to address the convention body.

Mike Bekaert, a representative of Senator Mike Round's office, was present to address the convention delegates on behalf of Senator Rounds.

Department of South Dakota Disabled American Veterans Commander, Don Sealock, was introduced and delivered greetings.

Jack Dean, representing the Vietnam Veterans of America, Department of South Dakota brought greetings from that organization.

Director of the Sioux Falls VA Health Care System, Lisa Simoneau, and Shawn Fields from the Sioux Falls Regional VA System were introduced by the Chair and brought greetings from their respective agencies.



At this point, Department Commander Nelson called NEC Jim Huls to the podium for the purpose of an introduction. NEC Huls introduced National Commander Candidate, V. James Troiola, of New York to address the body of the convention.



The South Dakota American Legion Auxiliary President, Teresa Huntimer and National Executive Committeewoman, Susie Clyde, brought greetings from the Auxiliary.

Greg Whitlock, Secretary of the SD Department of Veterans Affairs was introduced and addressed the assembly.



Department Commander Nelson introduced Krisma DeWitt of Watertown, Chairman of the Convention Credentials Committee, for the purpose of providing the Credentials Committee's initial report. Chairman DeWitt presented that report to the Convention.



Commander Nelson then introduced PDC Tim Jurgens of Milbank, SD, Chairman of the Convention Rules Committee, for the purpose of a report. PDC Jurgens presented that committee's report to the Convention.

CONVENTION RULES COMMITTEE REPORT

The meeting of the Convention Rules Committee was called to order by Chairman Tim Jurgens of Milbank at 1:30p.m., Friday, June 25, 2021, at the Huron Event Center in Huron SD.

Cynthia Douglas of Rapid City was appointed Secretary.

Chairman Jurgens led the Pledge of Allegiance and Liason Terry Hanson of Arlington read the duties of the Convention Rules Committee on page 7 of the Uniform Code of Procedures.

The committee reviewed 0 resolutions.

There being no further business to come before the committee, Ted Kimball of District 4 made a motion to adjourn, seconded by Mike Pauling of District 1, the Convention Rules Committee meeting was declared adjourned at 1:37 p.m.

CONVENTION AMERICANISM COMMITTEE REPORT

Mr. Commander:

The meeting of the Convention Americanism Committee was called to order by Chairman Doug Harris of Rapid City on Friday, June 25, 2021, at 1:30 p.m., at the Huron Event Center in Huron, SD.

Present besides Chairman Doug Harris of Rapid City and Liaison Bill Peters of Sioux Falls were the following: District 1 – Ken Sabers of Sturgis Post 33;

District 2 – Doug Harris of Rapid City Post 22; District 3 – No representative;

District 4 – Dale Strom of Aberdeen Post 24; District 5 – Noel Cummins of Milbank Post 9; District 6 – Annette Dunham of Iroquois Post 280; District 7 – Shane Lamer of Montrose, Post 154; and District 8 – Wayne Brandt of Yankton, Post 12.

Colors were saluted. Annette Dunham led the invocation. Chairman Harris led the Pledge of Allegiance and read the duties of the Convention Americanism Committee on page 6 of the Uniform Code of Procedures.

Bill Peters, Sioux Falls Post 15, was appointed as secretary.

The Convention Americanism Committee reviewed 1 Resolution:

Convention Resolution No. 21-2 was drafted by Clay Kaiser of Post 92, The Resolve clauses states: The Department of South Dakota American Legion Public Safety Committee will oversee in cooperation with the South Dakota Highway Patrol, a South Dakota Youth Trooper Academy; and be it further

Resolved, the Finance Commission will ensure a yearly line item is included on the annual budget to fund The American Legion of South Dakota's Youth Trooper Academy requirements; and be it further

Resolved, The Department of South Dakota American Legion in Annual Convention assembled 24-27 June 2021 in Huron South Dakota, will officially and fully endorse the South Dakota Youth Trooper Academy. Discussion was held.

Dale Strom of Aberdeen moved to adopt the Resolution and Noel Cummins of Milbank seconded the motion, additional discussion was held. Vote taken. Motion carried.

Additional discussion was held regarding other Americanism programs.

- 1. Oratorical Program timelines were announced by Chairman Harris. Local contests must be completed by January 9th, 2022. District contests must be completed by January 30th, 2022. The district competition dates must be provided to Department by the District Commanders or their representative NLT 15 August 2021. The competition will take place at Midwinter in Oacoma on the 20th of February 2022.
- 2. Youth Trooper Academy will be held on 12 16 July with "Blue Hat" day taking place on the 15th. All Legionnaires are invited to attend.
- 3. Boys State was held from 31 May through 4 June and included both Juniors and Seniors. The Americanism Commission at their annual meeting in June approved a motion to support the continued inclusion of both Juniors and Seniors into this program. Chairman Harris has passed this information to the Boys State Corporation. He also reported that the Boys State Corporation is still debating on whether to continue allowing Seniors to attend. They will also discuss and decide whether or not to allow a boy to attend two years in a row. More information on Boys State will be provided

by the Deputy Director of Boys State during the convention. Larry Price pointed out to the committee that the only way the rules on who can attend and who is eligible for scholarships (specifically the Samsung), is to author and offer a resolution at the National Convention.

Chairman Harris opened the floor for any other items for the good of Americanism. No further comments were offered.

There being no further business to come before the committee, after the benediction and a salute to the Flag, Chairman Harris declared the Convention Americanism Committee meeting adjourned at 2:21 P.M.

Chairman Holmes led the Pledge of Allegiance and read the duties of the Convention Resolutions Committee on page 18 of the Uniform Code of Procedures.

Gene Opbroek of Gregory was appointed as secretary.

The Convention Resolutions Committee drafted 3 resolution(s).

Convention Resolution SDAL 21-15 was drafted by the Convention Resolutions Committee to express thanks to Huron Post 7, for hosting a great convention.

Dwight Stadler made a motion, seconded by Gary Watts, to Recommend Do Pass. Motion carried.

Convention Resolution SDAL 21-16 was drafted by the Convention Resolutions Committee. The resolve clause states: By the American Legion, Department of South Dakota, in regular meeting assembled in the 2021 Department Convention, held in Huron, South Dakota, June 24-27, 2021, that the Department of South Dakota American Legion establish The South Dakota American Legion Public Safety Committee as a standing committee with a supporting budget for five (5) members with 3-year rotating terms.

Moved by Dwight Stadler and seconded by Gary Watts to forward this resolution to Internal Organization Convention Committee. Motion carried.

Convention Resolution 21-17 was drafted by the resolutions committee. The resolved clause reads: by The American Legion, Department of South Dakota, in regular meeting assembled at the 2021 Department Convention held in Huron SD June 24-27, 2021, that the Department of South Dakota make permanent repair of the Flaming Fountain one of their top legislative priorities during the 2022 South Dakota Legislative Session.

A motion was made by Marv Tisdale and seconded by Dwight Stadler. Motion carried.

The Convention Resolutions Committee reviewed and referred a total of 5 Resolutions to the following Convention Committees.

Convention Resolution 21-1 was drafted by the Post 250, Castlewood.

The resolve clause states: by the American Legion Department of South Dakota, in regular meeting assembled in the 2020 Department Convention held in Huron, South Dakota, June 18-21, 2020, that the American Legion develop an "Operational Readiness Era" classification and a "Cold War Era" classification for veterans who do not fall into previously defined war eras.

A motion made by Gary Watts and seconded by Mark Winter to forward to the Internal Organization Convention Committee. Motion carried.

Convention Resolution 21-8 was drafted by the Post 250, Castlewood.

The resolve clause states: By the American Legion, Department of South Dakota, in regular meeting assembled in the 2021 Department Convention, held in Huron, South Dakota, June 24-27, 2021, that the Department of South Dakota American Legion establish The Training Committee as a standing committee with a supporting budget for five (5) members with 3-year rotating terms.

Dwight Stadler made the motion and seconded by Mark Winter to forward to Internal Organization Convention Committee. Motion carried.

Convention Resolution No. 21-10 was drafted by the Post 250 of Castlewood. The resolve clause states: by Post No. 250, The American Legion, Department of South Dakota, in regular meeting assembled in Huron, South Dakota June 24-27,

2021, That the Department of South Dakota establish the Membership and Marketing Committee as a Standing Committee; and, be it finally

RESOLVED, that said Membership and Marketing Committee will be made up of the Membership Chairman who will serve one-year terms, one representative from each Department Vice Commander's area and one representative from each District to serve three-year terms that are staggered for rotation, The Department shall establish the appropriate funding in place to support the committee.

Motion by Perry Schmidt and seconded by Mark Winter to forward to Internal Organization Convention Committee. Motion carried.

Convention Resolution No. 21-14 was drafted by Post 50 of Sisseton SD. The resolved clause states: By The American Legion, Department of South Dakota, in Annual Convention assembled, June 24-27, 2021, in Huron South Dakota, that The American Legion Department of South Dakota include into the employee handbook that a paid salaried employee on the department payroll, whether full time or part time, will be deemed ineligible to simultaneously hold both a salaried position and an elected leadership position with the department.

Motion by Dwight Stadler and seconded by Bob Kucera to forward to Internal Organization Convention Committee. Motion carried.

Convention Resolution No. 21-2 was drafted by Post 92 of Redfield. The resolve clauses states: The Department of South Dakota American Legion Public Safety Committee will oversee with cooperation with the South Dakota Highway Patrol, a South Dakota Youth Trooper Academy; and be it further. resolved, the Finance Commission will ensure a yearly line item is included on the annual budget to fund The American Legion of South Dakota's Youth Trooper Academy requirements; and be it further Resolved, The Department of South Dakota American Legion in Annual Convention assembled 24-27 June, 2021, in Huron South Dakota, will officially and fully endorse the South Dakota Youth Trooper Academy.

Moved by Marv Tisdale and seconded by Perry Schmidt to forward to Americanism Convention Committee. Motion carried.

There being no further business to come before the committee, the Convention Resolutions Committee meeting was recessed at 11:25 a.m. but all were reminded by Chairman Holmes that the Resolutions Convention Committee may reconvene at a later time if needed.

125-199 goal-size group — Clay Kiser American Legion Post #92 of Redfield with an increase of 105.26%.


200-299 goal-size group — Meade American Legion Post #33 of Sturgis with an increase of 103.97%.

There being no further business to come before the committee, the Convention Employment Committee meeting was declared adjourned.





ANNUAL REPORT OF THE DEPARTMENT ADJUTANT

Department Commander Nelson:

This report is being written and read to satisfy the requirement in the Constitution and By Laws which requires the Department Adjutant to write and present to each annual convention, a report covering all activities not covered in the annual reports of the Committee Chairs and other State American Legion officials. As this was my first year as the Department Adjutant, it has been quite a learning curve. Adding all the challenges the pandemic it has been a very interesting year.

The American Legion Department of South Dakota is a member of the South Dakota Veterans Council (SDVC) along with five other Veterans Service Organizations. The council meets approximately four times per year. The main goal of SDVC is to address and support issues involving veterans of South Dakota. The Council continues to raise money for the South Dakota Veterans Cemetery endowment fund through the South Dakota Community Foundation. Additionally, great progress is being made in completing the State Veterans Cemetery, giving a place on the east side of South Dakota for Veterans to honored as they are laid to rest. There is ongoing discussion on what to do with the building the SDCF owns on the South Dakota State Fair property. No decision has been made to date.

Due to the ongoing COVID-19 issues, many committee meetings as well as the Midwinter Convention were cancelled for 2021. District Spring meetings for 2020 were cancelled, so elections of District Commander for the even years was held during District Fall meetings. Even though many committees did not meet in person, a number of meetings were held via Zoom to meet deadlines and to ensure business was accomplished. I am happy to report District Spring meetings for 2021 were held as scheduled.

The Department Executive Committee (DEC) received a request from the Department Assistant Adjutant and news paper editor, Courtney Van Zanten, to allow the South Dakota Legion News to be sent to all South Dakota Legion members. Courtney felt Legion information was not making it to the Legionnaires due to the cancellation of many meetings as well as many Post refraining from holding meetings due to the pandemic. Courtney proposed off setting the cost of the paper by allowing advertisement by businesses. The DEC approved the request for a one-year test, and they would reconsider it again after the test period.

The Department usually purchases a new vehicle every three years. However, due to the increase in the price of vehicles, the amount that had previously set aside for the purchase was determined to not cover the cost of a vehicle. The decision was made to delay the purchase for one year to save additional money for the vehicle purchase.

The transition to the new MyLegion and the Personify Pgo system by national headquarters has not gone as well as expected. It has impacted the staff's ability to process memberships as well as

view reports and limited the assistance we could give to Posts. I certainly hope national headquarters can correct the issues and the systems allow us to conduct business in a timely manner.

Judy Greenfield and Mary Jo Boner continue to make the headquarters office successful. They have been instrumental in ensuring our department functions and programs succeed. I certainly could not have made it through my first year as Adjutant without their help and dedication.



Since most of the Committee Chairs and State Officers have filed their reports which will be available on the Department website for review, most of the activities have been covered and reported on.

AMERICANISM COMMISSION CHAIRMAN REPORT

Commander Nelson:

Disclaimer: This report was due prior to Boys State, and the State Convention, so some of the verbiage will be "future tense" and some "past tense". I know that's confusing but imagine trying to write it under those circumstances. The report you are given at the convention will most likely change, to reflect the latest situation.

Thank you, Commander Nelson for the opportunity to serve as your Americanism Chairman for the last two years.

Greetings to my fellow Legionnaires! On behalf of the Americanism Commission, I welcome you to the 2021 convention and encourage you to have a great time telling the other members how much fun you had presenting the Americanism programs in your community. As someone who grew up taking part in these programs, I can tell you that the impact they have on our youth is truly amazing. I know it has been much harder to get into the schools, community events were canceled, and other youth programs such as 4-H and Scouting were limited, but you persevered. Thank you!

Since this is an annual report, I will take a few minutes to cover the different programs in a little detail. First, the Oratorical Program. This is the only program that managed to make it through the pandemic without being canceled. We had six competitors this year (up from five last year) and the quality of the presentations was impressive. For the second year in a row, National canceled their competition, but this year, they announced slightly ahead of time that they would be presenting a \$5,000 scholarship to those individuals who won at the Department level. That was a huge improvement over the \$2,000 they awarded last year. It also helps make marketing a little easier. Fiala Herceg, from Aberdeen, took first place this year (her second year of competing) and walked away with \$6,000 in scholarship monies. Thank you to all the volunteers and "voluntolds" who helped with the last two years competitions! Now for a bit of a "side note": As my Post interviewed the candidates for Boys State this year, I found that several of them were members of the debate team. If you have boys and girls like this, you should actively recruit them to take part in this program next year.

Boys State 2021 moved forward after being canceled in 2020 and was held "in-person" with both Juniors and Seniors being eligible. The dates for this year were May 31st – June 4th and approximately 275 boys are expected to attend, up from about 240 in 2019. Legion Day will be held on Thursday the 3rd of June, so come on up and observe Boys State in action. Spend the day in Aberdeen and hang around to watch your boys compete in the annual Boys State Olympics that evening. Despite missing a year and losing the recruiting help of the 2019 Boys Staters to graduation, you still managed to recruit a large number of participants. There will also be an increased number of new counselors at Boys State this year as our Director attempts to build "depth" into the staff. A huge thank you to all those legionnaires and SD Army Guard members who believe in this program and volunteer their time to make it the success it is. Finally, thanks again to SDAL Foundation for the \$2,000 grant to this program!

Youth Trooper Academy is also moving forward for an in-person session this year after being canceled in 2020. The date was changed from the normal June timeframe to July $12-16^{th}$ due to scheduling conflicts. The 24 statewide participants have been selected and notified. If you are sponsoring a participant, remember to get your tuition check (\$200) sent to Department ASAP. One of the great measures of success with this program is that there are now four past participants who wear a South Dakota Trooper uniform. Legion Day for YTA will be Thursday July 15^{th} . It's always exciting to watch our youth in action as they dress up in padded gear to "meet" the police dog, check out the SWAT vehicles and fire police weapons. A special thank you to the South Dakota Troopers who helped recruit, plan and administer this program, and to Larry Price who works closely with them.

Many of you have already started the American Legion Baseball season and will be busy coaching, travelling with, and supporting your players this summer. Thank you to all those Posts out there who make this possible. While the 2020 season wasn't canceled, there were still many challenges caused by the pandemic. Things promise to be mostly "back to normal" this year with a state competition, National Regional competition and a national competition. Of special note, Post 22 Baseball in Rapid City was awarded the 2022 and 2023 National Regional tournaments; come and check out their brand-new stadium. Finally, a huge thank you to the members of the SDAL Athletic Commission who work tirelessly to bring it all together. Support your local teams by attending their games!

South Dakota Scouting continues to march on. Thank you to those Posts' and individual Legionnaires who work year after year to help mentor our youth through their sponsorship/support of Scout Troops. If your post does not have a troop, but would like to help, remember that you can co-sponsor a troop in your area. Existing troops can always use financial support and volunteers. If you do sponsor or co-sponsor a troop, remember to submit your Eagle Scouts for the annual "Eagle Scout of the Year" competition. Thank you to Rick MacDonald who continues to lead by example as the SD Americanism representative to Scouting.

South Dakota's Junior Shooting Sports teams continue to be competitive. At least one of our shooters has been invited to take place in the national competition in Colorado Springs in 2021. 2020 was a successful year for the Pierre Post 8 shooters and their coach Sean Kruger, as they were awarded 3rd place in team competition at the national level. Thank you to the coaches and mentors of our teams who teach our youth gun safety and the joy of competition!

Finally, I would like to again mention the changes the Commission has made over the last two years. We've worked hard to provide the Posts with tools they can use to market our programs. The "Big 3" was created to provide posts with a simple, all-in-one information sheet that could easily be updated, posted, printed off and distributed to schools and students. We also built a "roadmap" for how, and to whom you should promote the "Big 3". We hope this helps the Post train their Americanism Officers and other members. We attempted to help the Post Americanism Officers by updating the Post Americanism Report to include explanations for the many different categories and providing them with an example of a winning report. We



worked closely with the Boys State staff and Northern State University to create other attractive marketing materials. A very special thank you goes out to Mary Jo Boner at Department Headquarters. She was our biggest supporter and hardest worker in bringing this all together.

It has been a pleasure serving as your Department Americanism Chairman for the last two years. I hope I, and the members of the Americanism Commission have helped bring our programs into the 21st century and provided you with helpful tools to make your jobs easier. Please take

advantage of those tools and feel free to offer suggestions on how we can continue to improve them. I hope to see you all at the Department Convention in Huron.

BLACK HILLS NATIONAL CEMETERY **COMMITTEE REPORT**

Commander,

I am pleased to serve as the chairman of the National Cemetery Committee, and I am honored to submit this annual report. The Black Hills National Cemetery is located just outside of Sturgis in the beautiful Black Hills. The Cemetery has over 30,000 interned and conducts over 900 funerals a year. The Bureau of Land Management recently donated an additional 180 acres. This extra space will take the facility well into the next century.

The committee I chair is small as there are only two of us; myself and Brian Dean. We make up in enthusiasm with what we lack in numbers. Our committee sits on the Black Hills National Cemetery Advisory Board, which provides the Department with a voice on the Cemetery's operations. We serve as a liaison to the Cemetery's Director. The Board conducts numerous fund-raising events throughout the year, with the monies raised going directly to the Cemetery for projects that exceed the Cemetery's funding from the VA. We are currently working on moving several trees to block the view of some newly constructed private buildings. We are also finalizing plans to upgrade the flag poles located throughout the Cemetery, including the Avenue of Flags. The upgrading of the flag poles is a long-term endeavor, with 18 planned for this year. These two projects alone will be funded by some of the \$17,000 contributed by the Advisory Board.

The South Dakota American Legion is responsible for the Memorial Day Ceremony at Black Hills National Cemetery on an every other year basis. The Department of South Dakota's National Cemetery Committee is responsible for the planning and organizing the Memorial Day Ceremony. This year we planned for a complete Memorial Day Ceremony on-site, but due to COVID and the VA restrictions, no more than 20 people will be allowed. Given these restrictions, it will be a small and relatively private ceremony with the posting of colors, the National Anthem, a volley of three, and the playing of taps. We will place a limited number of wreaths and will have a chaplain's prayer. God willing, we can get back to normal next year

That is the long and short of what our committee has done for the National Cemetery Committee this past year. I hope we have provided you with helpful information.

Zero TFA Claims!

First of all, I want to thank the SD American Legion Foundation for the \$1,500.00 of Grant Funds to the Children and Youth Committee. The funds were used to procure backpacks filled with school supplies for children of all ages going into the 2020-2021 school year.

Before the Backpack Program started Operation Homefront reached out. Operation Homefront's mission is to build strong, stable, and secure military families so they can thrive — not simply struggle to get by — in the communities they have worked so hard to protect. The representative from Operation Homefront informed the Children & Youth Committee of their annual 2020 School Supply drive through Dollar Tree stores. The drive is based on donations at checkout with miscellaneous school supplies from glue sticks to paper. Children & Youth volunteers signed up at several Dollar Tree store locations to include: (3) Sioux Falls, (2) Mitchell, (1) Watertown, and (1) Aberdeen. Once a week the volunteers did a pickup at each of their designated locations of school supplies for four weeks in July during the drive. The representative of Operation Homefront encouraged us to give them to veteran children in need first and if those needs were met in the area to broaden the scope to the surrounding community children that would also benefit. Their goal was to help in any way!

In the beginning of August, all school supply donations and purchased backpacks through the South Dakota American Legion Foundation were centralized to the Chester American Legion Auxiliary, where volunteers sorted supplies, stuffed backpacks for distribution.

In total, with the Grant Funds 335 backpacks, and 24 teacher bags carrying 3,902 school supplies from the above-mentioned Dollar Tree stores from the Operation Homefront 2020 drive made their way out the door to 335 deserving children from veteran children to the reservation children, Department of Social Services children, and to school representatives handing them to their most needy within their grasp. Each and every representative could not have been more thankful especially this year!

The Backpack Program involved the following recipients from the Sioux Falls Army National Guard, and the following communities: Watertown, Mt. Vernon, Aberdeen, Rosebud, Faith, Mitchell, Brandon, Garretson, Chester, Eagle Butte,

White Lake, Chamberlain, Alexandria, Wessington Springs, Huron, and Stickney/Corsica.

The next drive was the Toy Drive! We teamed up with Dollar tree, Operation Home Front and the SD AL Foundation for another great experience I was able to be a part of! Handing these bags out before Christmas filled with toys to

children was a complete joy! The veteran families that received them were very thankful this season.

Total of donated items from dollar trees: 5,647. The SD AL Foundation donated \$750 for 750 gift bags for the toys to be put it. These gift bags went out to the deployed South Dakota units and the units currently going through medical in Sioux Falls during the holidays.

Annually, the brochure and application processes are reviewed. No monies were added to the fund from the Department's outside income programs. More specific details can be obtained from State Headquarters, your District Education Loan Chairperson, or a member of the state Education Scholarship Committee. The state committee consists of Jerry Mencke, Huron, Paul Weidenbach, Lesterville, Michael Pauling, Piedmont, Philip Egeberg, Brookings, Ed Hruska Jr., Sioux Falls, and Hugh Holmes, Mitchell.

Among the many great things the American Legion does for veterans, promoting the employment and retention of veterans is one of them. Veterans bring unique skills to any organization. In addition to excellent technical education and training, veterans have a wealth of experience in a broad range of areas, not the least of which is leadership. INTERNAL AFFAIRS COMMISSION CHAIRMAN REPORT

Fellow Legionnaires,

I would like to thank Commander Nelson for appointing me to serve as the Chairman for the Internal Affairs Commission for 2021.

The Internal Affairs Commission met 3 times by ZOOM conference to accomplish its mission. On 26 April 2021, 11May 2021, and 20 May 2021. A quorum was present at all three of the zoom conferences.

The Constitution of the American Legion, Department of South Dakota, provides in Article XV, Section 1, that "Any amendment to this constitution may be proposed by any Post, or by the Department Standing Committee on Constitution and Bylaws. Any amendment proposed by a Post shall be submitted in writing to Department Headquarters at least six weeks prior to the annual Department Convention."

"The Department Adjutant shall present it immediately to the Department Commission on Internal Affairs. At least 30 days prior to said convention, the Department Commission on Internal Affairs shall transmit to all Posts, through Department Headquarters, a full copy of all amendments submitted by Posts, together with the favorable or unfavorable recommendation of the committee thereon, with a brief statement of reasons for such recommendation, and at the time the committee shall in like manner, distribute to all Posts, full copy of any proposed amendment originating with the committee itself."

Any resolution pertaining to changes of the constitution and bylaws of the Department of South Dakota American Legion must be submitted to State Headquarters no later than six weeks prior to the state convention, for consideration by the Internal Affairs Commission.

The only way the American Legion is able to change, and grow is with resolutions submitted by the local Posts within the Department.

There are several resolutions that have been submitted this year to the Internal Affairs Commission for consideration.

The resolution SDAL 21-1 was submitted by Post 250 of Castlewood was to develop an Operational Readiness Era Classification and a Cold war era classification for veterans who do not fall into previously defined war eras.

THE COMMISSION VOTED TO SEND THIS RESOLUTION TO THE CONVENTION RESOLUTIONS COMMITTEE WITH A DO NOT PASS RECOMMENDATION.

Resolution SDAL 21-2 was submitted by Post 92 of Redfield. This resolution would make the Youth Trooper Academy an official program of the South Dakota American Legion in cooperation of the South Dakota Highway Patrol, however we would request a line item in the annual budget to fund the program.

THE COMMISION RECOMMENDED REMOVE THE $2^{\rm ND}$ RESOLVE CLAUSE AND A DO PASS FOR THIS RESOLUTION.

Resolution SDAL 21-3 was submitted by the Internal Affairs commission that would change the name of Shannon County in the State Constitution in District 2, to read Oglala Lakota county in District 2 Department of South Dakota American Legion. THE COMMISSION RECOMMENDED A DO PASS FOR THIS RESOLUTION.

Resolution SDAL 21-4 was submitted by the Internal Affairs Commission that would amend the constitution of the Department of South Dakota Legion to read as: For God and Country we associate ourselves together for the following purposes: To uphold and defend the Constitution of the United States of America; to maintain law and order; .to foster and perpetuate a one hundred Americanism' to preserve the memories and incidents of our associations in ALL WARS; to inculcate a sense of individual obligation to the community, state and nation; to combat the autocracy of both the classes and the masses; to make right the master of might; to promote peace and good will on earth; to safeguard and transmit to posterity the principles of justice, freedom and democracy; to consecrate and sanctify our comradeship by our devotion to mutual helpfulness.

THE COMMISSION VOTED A DO PASS FOR THIS RESOLUTION.

Resolution SDAL 21-5 was submitted by Post 88 in White would remove the financial limit set forth in the Constitution for the Children and Youth committee and have the Finance Commission create a line item in the annual budget for an amount not to exceed \$300.00 for the Children and Youth Committee.

THE COMMISSION MOVED TO AMEND THE RESOLVED CLAUSE TO READ, "THAT LINE ITEMS BE CREATED IN THE DEPARTMENT BUDGET, PROPOSED BY THE DEPARTMENT FINANCE COMMISSION AND APPROVED BY THE EXECUTIVE COMMITTEE" AND VOTED FOR A DO PASS FOR THIS RESOLUTION.

Resolution SDAL 21-6 was submitted by Post 88 in White to allow for changes in voting procedures during the time of National pandemics or other emergencies when regular attendance at the Annual State convention is impossible due to the better interest of public health.

THE COMMISSION RECOMMMENDED A DO NOT PASS FOR THIS RESOLUTION AND ALSO RECOMMENDED FURTHER STUDY ON THE CONCEPT.

<u>Resolution SDAL 21-7</u> submitted by post 88 in White would set the installation date of newly elected District Commanders to coincide with the election and installation of the newly elected Department Commander at the annual State Convention.

THE COMMISSIOON VOTED TO RECOMMEND DO PASS OF THIS RESOLUTION.

<u>Resolution SDAL 21-8</u> was submitted by Post 250 of Castlewood to establish the Training Committee as a Standing committee with a supporting budget for Five members with Three-year rotating terms.

THE COMMITTEE RECOMMENDED TO SEND THIS TO THE CONVENTION RESOLUTIONS COMMITTEE AS IT DID NOT REQUIRE A CONSTITUTIONAL CHANGE.

Resolution SDAL 21-9 was submitted by Post 250 in Castlewood ensure that minutes from each committee meeting are disseminate to every chartered post within 30 days of the committee meeting.

THE COMMISSION VOTED A DO NOT PASS OF THIS RESOLUTION.

Resolution SDAL 21-10 was submitted by post 250 in Castlewood and would require that membership of the Membership and Marketing committee will be made up of the Committee chairman for a 1-year term, and a representative from each Department Vice Commanders areas and from each District to serve staggered threeyear terms. The membership and marketing committee shall be established as a Standing Committee. Appropriate funding shall be in place to support the committee. THE COMMITTEE VOTED TO SEND THIS RESOLUTION TO THE CONVENTION RESOLUTIONS COMMITTEE.

Resolution SDAL 21-11 was submitted by the Internal Affairs Commission to accurately reflect in the Constitution and By-Laws the Committees, Commissions, Convention Committees, and Temporary Committees that currently exist in the American Legion, Department of South Dakota.

THE COMMISSION VOTED A DO-PASS RECOMMENDATION TO THIS RESOLUTION.

Resolution SDAL-21-12 was submitted by Post 250 of Castlewood proposes that Department Vice-Commanders have the ability to direct and make official visits to Districts, Posts and events on the behalf of the Department for the good of the American Legion without restriction or the need for an official call from the Department Commander and the allotted amount under the budget to assist with their expenses.

THE COMMISSION VOTED A DO NOT PASS RECOMMENDATION TO THIS RESOLUTION.

Resolution SDAL 21-13 submitted Post 250 of Castlewood requires replacing the eligibility dates in the constitution that read from 7 Dec 1941 to 31 December 1946, 25 June 1950 to 31 January 1955, 28 February 1961 to 7 May 1975, 20 December 1989 to 31 January 1990, and August 1990 to a date determined by the US Government to the phrase of "any time after 7 December 1941".

THE COMMISSION RECOMMENDS A DO PASS FOR THIS RESOLUTION.

Annual reports are welcome from the Sons of the American Legion and The



Sons of the American Legion Commander Legion Riders. Terry Hanson informed us that there are six new SAL Squadrons in South Dakota this year, however, there are a few Squadrons still having membership issues. Even so, South Dakota is extremely close to reaching an all-time high in membership. The Sons of the American Legion are a vital part of the American Legion Family and we are very fortunate to have the Sons a big part of our organization. Well done Commander Terry.

LEGISLATIVE COMMITTEE CHAIRMAN REPORT

Commander,

Here is the annual report of the South Dakota American Legion Legislative Committee. The members of the committee are Chairman Doug Feltman of Chamberlain, PDC Rod Martens of Piedmont, PDC Gary Watts of White, PDC Rick MacDonald of Hermosa and Chris "Van" Van Delist of Rapid City.

The lobbyists for this year were Doug Feltman, Adjutant Kevin Hemple, PDC Byron Callies and Chris "Van" Van Delist.

Because of Covid, the Legislative Round tables were cancelled this year. In light of that The SD Veterans Council met on the 13th of January 2021 at Post # 8 in Pierre. I attended the meeting as a guest. The Council discussed the bills that were likely to be of a concern to Veterans and set the Council's priorities. That evening the Veterans Council hosted a Legislative reception with all Legislators invited and it was well attended by the Veterans Council and Legislators.

On the 10th of February 2021 the Legislative Committee met in Pierre at Post # 8. Roll called showed the following committee members present: Chairman Doug Feltman, PDC Gary Watts, Chris "Van" Van Delist. Committee men Rick MacDonald and Rod Martens attended by Zoom. Also in attendance were State Commander Fred Nelson, Adjutant Kevin Hemple, NEC Jim Huls and Lobbyist Byron Callies,

Adjutant Hemple summarized the Veterans Council meeting. The Legislative Committee then reviewed and discussed 27 bills, and a decision was made on each on how we were going to proceed.

There were 13 House bills that were discussed, and we were going to: watch 4, support 7, do not support 1, and no action on 1 as it was defeated in the House committee.

There were also 14 Senate bills that were discussed, and we were going to: watch 6, support 2, lobby in support of 2 and remove 4 from the list.

There was one Senate Resolution that was placed on the watch list also.

The evening reception was hosted by Post # 8. All Legislators received a written invitation, and it was well attended. This reception gave the Legislative Committee, the Legion Lobbyist, and Legionnaires an opportunity to meet the Legislators, get to know them and give them our recommendations and thoughts on particular bills that had an impact on Veterans. At both receptions while talking to the Legislators, it is very obvious that The South Dakota American Legion has a good and respected relationship with the Legislators in the State.

Post # 8 again did an excellent job in hosting the reception and served a delicious supper to all in attendance. Thank you. If anyone wants more information on a particular bill, please contact me at (605) 234-4143. Here is the results of the bills on the Legislative Committee's list:

HB 1033 - update certain provisions relating to the SD retirement system - Signed by the Governor

HB 1055 - authorize certain children eligible for registration with a state-approved distance learning - Signed by the Governor

HB 1057 - establish resident tuition requirements for veterans and armed forced personnel and family members - Signed by the Governor

HB 10-65 - adopt the emergency medical personnel licensure interstate compact -Signed by the Governor

HB 1122- require official declaration of war before the National Guard may be deployed overseas - Deferred to the 41st. day

HB 1206 - increase the allowable3 reimbursement for certain headstones for military personnel - Tabled

HB 1276 - appropriation for capital improvements to the State Veterans Home -**Tabled**

HB 1277 - appropriation for the installation of a sprinkler system at the State Veterans Cemetery - Tabled

SB 27 - revise off-campus tuition rates at institutions governed by the Board of Regents - Signed by the Governor

SB 33 - appropriation for certain costs related to the commissioning of the USS

Pierre - Signed by the Governor

SB 65 - create an exception to the dual compensation prohibition for state employees for military service - Signed by the Governor

SB 81 - authorize certain flags and flagpoles to be located on residential property within a community improvement district - Signed by the Governor

SB 84 - appropriate finds to support Veterans Memorial Centers in South Dakota -**Tabled**

SB 151 - appropriation to provide for infrastructure to support Ellsworth Air Force Base - Tabled

SB 180 - revise certain provisions regarding revenues generated by and donations to the South Dakota State Veterans Cemetery - Signed by the Governor

SB 181 - make an appropriation for road improvements leading to the State Veterans Cemetery - Signed by the Governor

SB 188 - appropriation to the Department of Veterans Affairs for the South Dakota State Veterans Cemetery - Tabled

SR 701 - resolution in support of rescinding the Medals of Honor given to Unites States soldier for the involvement and participation of the soldiers in the Wounded Knee Massacre of 1890 - Adopt as amended

What a year 2020 has been. What started out to be a projected bad year ended up quite the opposite. The committee met once this past year and agree that the fund keep the present account objective of mid-conservative. The fund has averaged 26.61% annual yield. The year-end market value as of April 28, 2020 was \$551,906, compared to a year end market value on April 30, 2021 of \$704,856. The current asset allocation for the trust is as follows:



Cash Alternatives is 2.1% which currently yields 0.02%; Fixed Income 33.8% with an average yield of 2.92%; Equities is 59.2% with an average yield of 1.06%; Real Assets is 2.1% with an average yield of .01%, Alternative investments 2.9% with an average yield of 5.89%.

The committee met with the investment manager and agreed to monitor the fund as needed in the coming year. We hope the fund will continue to perform in the coming year.

Resolution No. SDAL 21-1

Submitted by Olson Reid American Legion Post 250, Castlewood

Title: Develop Operational Readiness Era/Cold War Era War Eras **RESOLVED**, By the American Legion Department of South Dakota, in regular meeting assembled in the 2021 Department Convention held in Huron, South Dakota, June 24-27, 2021, that the American Legion develop an "Operational Readiness Era" classification and a "Cold War Era" classification for veterans who do not fall into previously defined war eras.

Title: Constitution of the Department of SDAL is amended to match the National Organization (Association to Associations and War to Wars)

RESOLVED, By the Internal Affairs Commission of the South Dakota American Legion in regular meeting on 20 April 2021, in a ZOOM meeting, That the Preamble to the Constitution of the Department of South Dakota American Legion is amended to read:

"For God and Country, we associate ourselves together for the following purposes: To uphold and defend the Constitution of the United States; to maintain law and order; to foster and perpetuate a one hundred Americanism; to preserve the memories and incidents in our associations in all wars; to inculcate a sense of individual obligation to the community, state and nation; to combat the autocracy of both the classes and the masses; to make right the master of might; to promote peace and good will on earth; to safeguard and transmit to posterity the principle of justice, freedom and democracy; to consecrate and sanctify our comradeship by our devotion to mutual helpfulness."

The resolution was adopted.

Resolution No. SDAL 21-5

Submitted by Higgins-Jessen Post #88 of White, SD.

Title: The Constitution of the Department of South Dakota, Article VI, Section 2.b shall be amended to remove the \$300 restriction

RESOLVED, By the Higgins-Jessen Post 88, of The American Legion of South Dakota assembled at their Meeting at White, SD, August 31, 2020, The Constitution of the Department of South Dakota, Article VI, Section 2.b shall be amended to remove the \$300 restriction to read:

"That a line item be created in the Department Budget, proposed by the Department Finance Commission and approved by the Department Executive Committee for The Music and Parade fund for the promotion, expenses, and participation of musical organizations at the annual Department Convention; and for The Department VAVS Committee, for the assistance to volunteer services at the three Veterans Administration Medical Centers in South Dakota, and the State Veterans Home in Hot Springs. Such expenditures are to be approved by the chairperson of the VAVS Committee; and for The Department Children and Youth Committee, provided that a sum not to exceed \$300 per year be allowed for the necessary travel and expenses by the chairperson of the Department Children and Youth Committee."

The resolution was adopted.

Resolution No. SDAL 21-6

Submitted by Higgins-Jessen-Olson Post #88, of White SD.

Title: The Department Constitution of The Department of South Dakota shall be amended to allow for casting ballots in the event that the Department Annual Convention must be cancelled due to a public health emergency

RESOLVED, By the Higgins-Jessen Post #88 of The American Legion of South Dakota assembled at their regular Meeting in White, South Dakota, March 29, 2021, The Department Constitution of The Department of South Dakota shall be amended to allow for casting ballots in the event that the Department Annual Convention must be cancelled due to a public health emergency, like the COVID-19 Pandemic; and be it further

RESOLVED, Article VIII shall be amended to add a new section: "Section 2. PUBLIC HEALTH EMERGENCIES – In the event of a State-government recognized public health emergency which may make attendance at the Annual Department Convention impossible due to attendance restrictions in the better interest of public health, the Department Executive Committee will deliberate and decide the fate of the immediate Annual Convention. If the Convention is canceled, the Department Executive Committee and Headquarters Staff will inform the Posts of the Department and work to assure Delegate Credentials are obtained and member addresses are verified in accordance with Article IV and reasonable timeliness to allow for mail-based voting."; and be it further

RESOLVED, Article IX shall be amended to add a new section: "Section 4. PUBLIC HEALTH EMERGENCIES:

- (a) In the event the Annual Department Convention is canceled in accordance with Article VIII-Section 2, the Department Executive Committee will develop a ballot that will be mailed to all duly appointed Post Delegates as defined by Article IV which will include:
- 1) Any candidates for open elected offices from declared candidates and eligible-incumbents, and
- 2) Any Resolutions that have been received according to Article XV
- (b) To allow reasonable discussion and to assure relevance of the election, completed ballots received within thirty calendar days of the start of the election shall be considered valid. All ballots that are received must be verified by the Department Executive Committee before the results of the election are announced.
- (c) As is current accepted practice at a "regular convention", if only one delegate's ballot is received from a Post by the deadline, it shall count as the entire Post vote in accordance with Article IV Section 2. Otherwise, Post votes will be allocated according to the proportion of votes which were received from the Post's delegates.
- (d) To encourage debate and prevent unintended long-term changes, any resolutions passed by absentee voting will have a "sun-set" expiration date of the next "normal" Department Annual Convention."; and

RESOLVED, The Department Executive Committee shall appropriately amend The South Dakota Uniform Code of

Procedure in accordance with Article IX, Section 1(b) to account for absentee voting during a canceled convention due to a public health emergency; and be it finally

RESOLVED, Once this resolution is approved, it shall be considered in immediate effect.

Such District Commander shall take office and assume his/her duties immediately upon his/her election their duties at the same time and place as the newly elected Department Commander is installed."; and be it further RESOLVED, During the time between the Spring Meeting and the Department Convention installation ceremony, the Outgoing and New District Commanders shall have all privileges of their office, understanding the Outgoing Commander is still the voting member of the Department Executive Committee until the New Commander is formally installed in office, and they shall work together to assure a smooth transition of responsibility and continued delivery of the Department's
