## PROCEEDINGS ONE-HUNDRED-THIRD ANNUAL CONVENTION THE AMERICAN LEGION

Department of South Dakota June 16-19, 2022

The Pre-Convention meeting of the American Legion Department Finance Commission was held at 10:00 a.m., Thursday, June 16, 2022, in The Whitewood Room at the Watertown Event Center, Watertown, South Dakota, followed by the meeting of the South Dakota American Legion Department Executive Committee, also in the Whitewood Room of the same facility, at 1:00 p.m.



The Convention Resolutions Committee's initial meeting was held at 10:00 a.m., Friday, June 17, 2022, in the Cattail Room in the Watertown Event Center, Watertown, South Dakota.

A break in the agenda at about 1:30 p.m. was announced so that Senator John Thune could address those present. He brought greetings and discussed current issues and concerns and entertained a few questions before his schedule required him to leave. The meetings of the other Convention Committees were held directly after Senator Thune's visit, in rooms so designated in the Event Center.

The South Dakota American Legion Foundation met in the Cattail Room at 3:00 p.m. A joint Convention, American Legion/American Legion Auxiliary, memorial service was held in the Heritage Theater of the Watertown Event Center at 4:30 p.m.

The American Legion/American Legion Auxiliary/Sons of The American Legion Joint Banquet was held at 7:00 p.m. on Friday, June 17, 2022, in the Cottonwood and Big Stone Rooms at the Watertown Event Center in Watertown, South Dakota with Daniel Seehafer, 2<sup>nd</sup> Leading Candidate for National Commander as the guest speaker.



The 103rd Annual Convention of The American Legion Department of South Dakota was called to order at 9:00 a.m., Saturday, June 18th, 2022, at the Watertown Event Center, Watertown, South Dakota, by Department Commander Gary Wolkow of De Smet, SD, after a mini concert by the State American Legion Band.

The Colors were advanced and posted by the Color Guard. The National Anthem was played. Department Commander Gary Wolkow led the delegates in the Pledge of Allegiance. The invocation was given by Reverend Dr. Mike Kumm, after which Department Adjutant Kevin Hempel conducted the POW/MIA ceremony. Department Commander Wolkow led the delegates in reciting the Preamble to the Constitution of The American Legion in unison.

The Call for Convention was read by Department Adjutant Kevin Hempel.

# OFFICIAL CALL FOR THE ONE-HUNDRED-THIRD ANNUAL CONVENTION OF THE AMERICAN LEGION DEPARTMENT OF SOUTH DAKOTA

The ONE-HUNDRED-THIRD ANNUAL CONVENTION of The American Legion Department of South Dakota is hereby called, and in conformity with action taken at the Ninety-Nineth Convention, will be held in Watertown, South Dakota, June 16, 17, 18, and 19, 2022.

### **PURPOSE**

The Convention is called to elect officers for the ensuing year and delegates to the 103rd National Convention of The American Legion, to consider any proposed amendments to the Constitution and to transact such other business as may be brought before it.

### REPRESENTATION

Representation at the convention will be by Posts. In accordance with the provisions of the Constitution, each Post is entitled to two delegates and two alternates plus one additional delegate and alternate for each fifty or major fraction thereof, memberships shown on the books of the State Adjutant fifteen days prior to the convention, or this year on June 1st, 2022. The Constitution requires that the delegates to the Department Convention be chosen by each Post by election from its own membership. Alternates will have power to vote only in the absence of the regular delegates.

Forms for listing the Department Convention Delegates and Alternates are sent to Post Adjutants. These forms need to be signed by the officers of the Post and mailed to reach State Headquarters, PO Box 67, Watertown, SD 57201 by June 15<sup>th</sup>, or turned in at the Department Convention Registration desk in Watertown. Note that the 2022 membership identification number of each Delegate and Alternate is required.

In accordance with the Department of South Dakota Constitution and Bylaws, Article IX, Section 3: Every Legionnaire attending the Department Convention shall register and pay a registration fee of \$1.00 and upon proper identification as a Legionnaire in good standing shall receive a Convention badge and be entitled to the privileges of the Convention. The Legion Post hosting the Department Convention shall retain this \$1.00 fee to help defray expenses incurred in holding the Convention. The registration fee for each Post's delegate strength, regardless of attendance, shall be \$7.00 per delegate payable to The American Legion Department of South Dakota, in advance of the election at the annual Department Convention. Department Headquarters shall retain \$2.00 of each delegate registration fee and forward the remaining \$5.00 to the Department Convention host Post to help defray Convention costs.

### DEPARTMENT EXECUTIVE COMMITTEE

A pre-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Watertown Event Center, Thursday, June 16, 2022, at 1:00 p.m.

A post-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Watertown Event Center, immediately following the adjournment of the 103rd Annual Department Convention of The American Legion Department of South Dakota.

### POST/DISTRICT OFFICIALS

Post and District Officials, unless elected as Delegates or Alternates to the Department Convention, have no privileges in the Convention except as guests of their respective Posts and Districts.

### CAUCUSES

Area Caucuses, for selection of State Vice Commander nominees, will be held in assigned areas, Saturday afternoon, June 18, 2022, immediately following completion of that day's convention business session.

### **CONVENTION COMMITTEES**

In accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, convention committees are to be convened for the purpose of compiling policy forming reports to the General Session of the Convention.

Each District shall designate Delegates or Alternates for service on each convention committee and shall file with the Department Adjutant a list of such designees at least two weeks prior to the convening date of the meetings of said convention committees. The convention committees consist of the following:

Credentials — 1 Delegate per District
Employment — 1 Delegate per District
Internal Organization — 1 Delegate per District
Legislative — 1 Delegate per District
National Security — 1 Delegate per District
Next Meeting Place — 1 Delegate per District
Rehabilitation — 1 Delegate per District
Resolutions —1 Delegate per District
Rules — 1 Delegate per District

The Department Commander will appoint Legionnaires, with membership in good standing, as the Chairperson and Liaison to each of the convention committees.

All convention committees will meet on Friday, June 17, 2022, at 1:30 p.m. at the Watertown Event Center, Watertown, SD, in rooms designated for that purpose. The directory of meeting rooms will be available upon entry into the Watertown Event Center on the day of the meetings and also in the Convention Program Book.

The Convention Resolutions Committee will hold its initial meeting, for the purpose of reviewing all convention resolutions to determine the distribution of said resolutions to the other convention committees, on Friday, June 17, 2022, at 10:00 a.m., in the Watertown Event Center, Watertown, SD. Room assignments will be announced in the Convention Program Book and will be posted in the convention facility.

Each convention committee chairperson will be responsible for compiling a final report of the actions of their respective committee to the Department Adjutant after their committee has adjourned and prior to the scheduled report of the convention committee to the convention body.

### RESOLUTIONS

Resolutions emanating from a Post shall be forwarded to the Department Adjutant to be in his hands no less than two days prior to the opening session of the Department Convention.

Resolutions which call for an amendment to the Constitution of The American Legion Department of South Dakota must be submitted to the Department Adjutant in the proper form by May 6, 2022. This will ensure that the Department Internal Affairs Commission can screen them in time to allow for the commission's recommendations for approval or disapproval and for the Department Adjutant to distribute copies of these resolutions to all Posts within the Department at least 30 days prior to the convening of the Department Convention.

### ELECTIONS

The election of all Department Officers as well as Delegates and Alternates to the 103rd National Convention of The American Legion, shall be a Special Order of Business of the Convention and in accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, will be conducted at 12 O'clock noon on Sunday, June 19, 2022, or at the conclusion of all other business of the Department Convention, whichever occurs first.

The assembly body gave a warm welcome to the Watertown Mayor, Reid Holien.

Convention host, Post #17 Commander, Dana Jones, delivered his greetings and welcomed the assembled delegates to Watertown.

State Vice Commander for Districts 3-8, Doug Feltman, responded to the welcome.

Department Commander Gary Wolkow called Department Vice Commander, Eugene Iron Shell Jr., Rosebud, and Doug Feltman, Chamberlain, to the podium. He then presented them with their Past Department Vice Commander's pins.

Senator Mike Rounds sent video greetings to the Convention Delegates and was received at this time.

Commander Gary Wolkow introduced Andrea Rose-Prehn, a representative from Congressman Dusty Johnson's office, who brought video greetings from South Dakota's lone Congressman to the United States House of Representatives to address the convention body.

The Chair then recognized the immediate Past Commander of the Veterans of Foreign Wars, Department of South Dakota, Danny Frisbe-Griffin, who brought greetings from their organization.

Department of South Dakota Disabled American Veterans Commander, Dan Francis, was introduced by Commander Wolkow, and delivered greetings.

Commander Wolkow introduced Roger Papka, representative of the Vietnam Veterans of America, Department of South Dakota, who brought greetings from that organization.

The Chair recognized Ken Teunissen who brought greetings from The Military Order of the Purple Heart.

Department Commander, Gary Wolkow, introduced the Deputy Secretary of the South Dakota Department of Veterans' Affairs, Aaron Pollard, who brought greetings to the assembled delegates and shared information about current issues.



At this point, Department Commander Wolkow called NEC Jim Huls to the podium for the purpose of an introduction. NEC Huls introduced National Commander Candidate, Daniel J. Seehafer from the Department of Wisconsin to address the body of the convention.

Salute the Colors. Chairman Madsen led the Pledge of Allegiance and read the duties of the Convention Americanism Committee in the Uniform Code of Procedures.

RESOLVED, That this resolution be forwarded to the National Adjutant of The American Legion for consideration at the 103rd Annual National Convention of The American Legion to be held in Milwaukee, Wisconsin, August 2022.

Dale Strom recommended a "Do Pass", as amended, with a second by Paul Jensen. Motion Carried

### Convention Resolution No. 22-12 was drafted by Gettysburg Post 135.

RESOLVED, By Ralph Leui Post #135, That the scholarships awarded for participants in the South Dakota High School Oratorical Scholarship Program "A Constitutional Speech Contest be as follows: for first place \$1,500, for second place \$1,000, for third place \$500 and Remaining finalists each receive \$200 each.

Motion by Ken Sabers, seconded by Dale Strom to recommend a "Do Pass", subject to approval by the Finance Committee.

Convention Resolution No. 22-14 was drafted by Milbank Post 9.

Motion by Paul Jensen to amend the Resolve Clause, second line, to read "Junior Legion A and B" and recommend a "Do Pass". Seconded by Ken Saber. Motion carried.

Resolved, That in commemoration of the 100<sup>th</sup> Anniversary of The Birthplace of American Legion Baseball that the State A, State B and Junior Legion A and B State Baseball Tournaments be held at the newly constructed Legion Field Complex in Milbank, SD Birthplace of American Legion Baseball in 2025 with final dates to be determined prior to the 2025 baseball season.

Convention Resolution No. 22-1 was drafted by Milbank Post 9.

The Asset and Infrastructure Review report recommended for our state building a new VA health care facility in Rapid City. They also recommended closing the Wagner VA Clinic as well as the Fort Meade hospital in Sturgis.

As for the Sioux Falls VA Medical Center, they recommended changing the emergency department into an urgent care facility.

I will not read the either resolution in its entirety because they are both rather lengthy, but I will give you the Resolve Clause as it is identical for both resolutions.

### Resolution No. SDAL 22-1, submitted by: AIR Working Group

RESOLVED, By The Department of South Dakota American Legion in State Convention assembled in Watertown, SD, June 16-19, 2022, That The American Legion urge Congress to enact legislation that prevents the VA from closing hospitals and community based outpatient clinics unless existing requisite community services, both inpatient and outpatient, that the VA currently provides are met or exceeded.

The committee felt strongly that the VA facilities in both Hot Springs and Fort Meade remain open and that the VA should not close or reduce any level of care for our veterans in any VA facilities including the community-based outpatient clinics that cares for our veterans. Jeff Hrabanek of Colome made the motion for a DO PASS recommendation and Eric Sorensen of Box Elder seconded the motion.

The motion to send resolution SDAL #22-1 to the convention floor with a DO PASS recommendation was passed.

### Resolution # SDAL 22-13 drafted by Badger Post 260


Jim Hornstra moved and Ward Champman seconded the motion amended as follows with a do pass recommendation:

members. I have the privilege of being elected as the Vice President of the SDVC and will do my best to ensure the Legion is well represented. The SDVC continues to discuss the selling of the Veteran's building at the State Fairgrounds. I have conveyed the Legion's stance that the building should remain a veteran's building, but I am afraid most of the VSO do not agree with my stance. I am sure the next year will continue to be interesting as the building continues to be a point of disagreement.

As stated last year, Judy Greenfield and Mary Jo Boner are mainstays in the office. They ensure the Department continues to function, membership is properly handled, and our various programs succeed. This office would not operate without their expertise and dedication.

Since most of the Committee Chairs and State Officers have filed their reports which will be available for review, most of the activities have been covered and reported on.


#### DEPARTMENT SERVICE OFFICER REPORT

#### AMERICANISM COMMISSION CHAIRMAN REPORT

Commander Wolkow,

What a busy year for the South Dakota American Legion Americanism program. Thank you for selecting me as the Americanism Chairman for the Department of South Dakota. Your leadership and willingness to direct my efforts for the year were greatly appreciated. Americanism is alive and well in South Dakota. Stepping into this position of State Americanism Commission Chairman, I had large shoes to fill. Anyone that knows me and my size 16 5E feet would not think that filling the shoes of our most recent Americanism Commission Chairmen, Doug Harris, and Larry Madison, would be a problem. With their help, I was quickly able to get a grasp of a program that many Posts in SD are participating in. Working with the Boys State, Youth Trooper, Educational Committee Chairmen, plus working with the Youth Program Administrator at State HQ, we made enhancements to the "Big 3" handout and wall posters by adding a QRC code (the square box with dots in it) to the front cover of each document. By seeing this code, our youth could take their cell phones out and snap a quick photo of the QRC code. When the student had time, they could open the photo and that code would automatically direct them to the web site

to find out more information about these programs or even directly navigate the student straight to the registration process.

In addition to the enhancements to the "Big 3" literature, I built on the groundwork that both Doug and Larry had started regarding the 4-H program in South Dakota. Youth today are so busy with sports, Church youth groups, 4-H and FFA. These are all fine activities to be a part of. When thinking about these activities, 4-H was the best organization to match up with many of our Legion Youth activities. A letter was created for the State 4-H leadership, informing them about the Americanism programs of the American Legion and how Post members from across the state could assist their local 4-H leaders by helping with oratorical activities/public speaking and shooting sports. Students that participate in 4-H develop leadership qualities that will aid them well when participating in Boys and Girls State. The collaboration letter was submitted to the state 4-H leadership which in turn was sent to each county 4-H extension office in SD. 4-H is good for all Americanism programs and likewise the Legion is good for 4-H. Posts are encouraged to help with 4-H as often as possible and 4-H students make up a good selection pool to recruit students from for our Americanism programs.

At the time of this report, only one of the "Big 3" programs have concluded for the year. This would be the Oratorical program. I would like to once again thank all of the volunteers that helped to Judge, escort, keep time, and monitor the contestants. We had six great contestants from around the state compete on the last day of Mid-Winter Conference (February 20th) at Arrowwood Cedar Shore Resort in Oacoma, SD. The winner of the State contest, Thomas Haar, representing Post 22 in Rapid City, advanced to the National Oratory competition held April  $22^{nd}$  - $24^{th}$  in Indianapolis, IN. Thomas did well in the competition, placing  $9^{th}$  overall. Congratulations on a job well done Thomas!! While this year's competition has completed, now is the time to spread the word about this program to our high school  $9^{th} - 12^{th}$  grade students. There are students that have the passion and drive to participate in the Oratory Contest. Please encourage them to compete in the years to come.

The 2022 Boy's State session is scheduled for May 30th - June 3rd in Aberdeen, SD. Boys from across the state will be traveling to this great event to learn about how Government works from the local township on up to the National level. Attendance is down this year significantly. This can be attributed to all the various activities and events that compete with the boy's time. Life experiences shape us all and these young men will learn about the rights and duties of a good citizen and what it takes to help promote change. Our way of government did not just happen. It was formed by those who came before us to help form a better way of life for us all. Let's encourage our young men to attend Boy's State to preserve our way of life and to help develop new leaders for our world tomorrow. Thank you to our Posts that sponsor these young men to attend this event at a cost of \$200 each. Blue cap day, held on the Thursday of every Boy's State, is a day that Posts can come out and check out the activities the Boy's go through. I encourage all Posts to take time in the coming years to stop in and check this out. Once again let us congratulate the 2021 Boys State Governor - Joseph Gebel of Mitchell on a job well done and for representing South Dakota over the past year.

The 2022 Youth Trooper Academy will be held in Pierre June 20<sup>th</sup> to the 24<sup>th</sup>. The YTA is an intensive week of living and learning the life of a typical cadet attending law enforcement training school. To help recruit tomorrow's new law enforcement members, this course was developed to inspire your men and women who sign up and are chosen to attend this fine program. Thank you to our Posts who sponsor these young men and women to attend this event at a cost of \$200 each. Don't forget about Blue Cap Day on Thursday June 23rd at the shooting range. Watch for details in the Up to Now on how to get there. Come and watch these young men and women participate in demonstrations from the drug dogs, swat team and run through shooting courses. Once again, let's congratulate the 2021 Youth Trooper Academy Scholarship winner – Wyatt Anderson of Bryant.

The American Legion and Scouting go hand in hand since the Boy Scouts was developed back in 1919. While attendance has dropped off over the years, it is important that the American Legion continues to stay involved with our local Scouting Squads, assisting them with funding, activities and even hands on training programs of the Scouting program. Our Boy Scouts will eventually grow into Eagle Scouts. The American Legion supports that program as well. The top Eagle Scout in the nation can earn a \$10,000 scholarship for college. If you know an Eagle Scout, we encourage you to have them fill out the American Legion Eagle Scout nomination form. Congratulations to our Eagle Scout of The Year – Riley Murphy – Summerset, SD. We encourage future applications to be turned in shortly after they are released for submittal by the state office. I would like to thank Rick MacDonald for his many years of leadership in the Scouting program. The current Chairman of the American Legion Scouting program in SD is Fred Nelson from Spearfish.

Another program you do not hear much about is the American Legion Junior Shooting Sports program. When you think of shooting programs, the programs of 4-H come to mind. 4-H is a great introduction to shooting sports, however there are several clubs that have been developed in many counties across the state where they come together at various sponsored events to compete against one another. All to educate and sharpen the shooting skills of these young shooters. These shooters compete in multiple events each year, such as NRA, American Legion or even in state shooting competition. Top shooters are recruited by Colleges or Military. There is one South Dakota Shooting Sport competition for the American Legion, held each year in Britton, SD in late March. Congratulations to Jenna Kruger from the Pierre Junior Shooters who is the South Dakota Sporter Champion and Jasmine Hayes from the Dakota Sharpshooters who is the South Dakota Precision Champion. Additionally, the Pierre Junior Shooters, sponsored by Post 8, is the Sporter Team State Champions and the Dakota Sharpshooters sponsored by Post 15 is the Precision Team State Champions. As a side note, Jordyn Ewine from North Dakota, but shoots with the Dakota Sharpshooters, has earned the title of Precision State Champion for North Dakota. Well done to all the youth shooters.

While we have talked about many of the "Hands On" programs under Americanism, we sometimes forget about many of the other activities that our Posts take part in each year that all fall under the Americanism umbrella. Activities such as; Operation Comport Warriors, Flag Education Program, School and Student programs - American Legion School Medal Award, American Education Week, Veterans in the Classroom, Reinvigoration Veteran Awareness, Citizenship - Get out and Vote Citizenship Outreach, and Committee on Children & Youth.

Our Posts capture their involvement with all these programs in their CPR and Americanism reports each year. The Americanism reports are submitted around Spring meetings each year. Winners of last year's Americanism reports can be found in the 2021 proceedings book. I encourage each Post to submit their Americanism report and be proud of what you have done as a Post.

Lastly, but not least, we finish out the year with Legion Baseball. Baseball can be noted in your CPR report, however most of the games are played in June and July. If your Post supports Legion Baseball, please be sure to find ways to support their needs over their season. If help is needed to support your team, ask your SAL group to help with gate working or fundraising. Ask your Auxiliary Units for the same help if needed. If your Post wants to start a team but is low on players, reach out to other Posts in your area to help find players. Registration will be completed by the time this report is printed. Please make sure that all background checks are completed for all adults that interact with the players and please make sure that your team has insurance. Our player's protection and wellbeing should be our priority. Let us have a great 2022 Legion Baseball season!

Some Posts are very active, and others are not. Small Posts can experience frustration as they may wish to be active but Post size, number of active members and geographical location can play a major part in the decline of activity and members over the years. Whatever your Post size, large or small, don't be afraid to brag about those activities and programs that you are active with. It's best to mark down the



activities you are involved with on both your Americanism and CPR report as you participate in that activity. These reports are used by National to help promote our programs with Congress to help our fellow Veterans and youth. Thank you for all that you do as a Post!

One final tournament to be held at Rapid City Post 22, is the Central Plains National Regional where teams from 4 states will compete for one spot to go to Shelby, NC to play in the American Legion World Series. Rapid City will host this Regional for the next 2 years. Also, this year's American Legion Golf Tournament will be hosted by the Post in Hartford on Sept 10th and 11th. This tournament is open to any Legion or Son of the American Legion member. It is a fun time so please try and make it to this event.

For next year, the 2023 State Tournaments have been awarded to : Class A Sr tournament – Yankton, Class A Jr tournament – Harrisburg, Class B Sr tournament – Redfield, and the Class B Jr tournament – Lennox.

We received one donation of \$100.00 in 2021.

Applications and brochures are online at **www.SDlegion.org**. We are currently revising the application for 2022/23 scholarship year.

The 2022 Educator of the Year packets were due May 1, 2022. Because the deadline for this article was May 3, 2022, the committee did not have time to review the packets. The winner will be announced at the state convention.

The education scholarships offered by the Department of South Dakota are for post-secondary education, college, or technical schools, for children of veterans,

grandchildren of veterans, and veterans, who meet the requirements as set forth in the Education Scholarship brochure. Please read the brochure for all the current changes. In all cases, the veteran listed on the application must be a member of the South Dakota The American Legion. The student must attend a higher education school in the state of South Dakota unless their plan of study not taught in a South Dakota school. The fund is self-sustaining through donations.

Annually, the brochure and application processes are reviewed. No monies were added to the fund from the Department's outside income programs. More specific details can be obtained from State Headquarters, your District Education Loan Chairperson, or a member of the state Education Scholarship Committee. The state committee consists of Jerry Mencke, Huron, Paul Weidenbach, Lesterville, James Moore, Burke, Perry Schmidt, Redfield, Shawnee Redbear, Pine Ridge, Michael Pauling, Piedmont, Philip Egeberg, Brookings, Ed Hruska Jr., Sioux Falls, and Hugh Holmes, Mitchell.

It has been an honor to serve this past year as the Chair of the Employment Committee, and to provide this report on their behalf. As Legionnaires, we have a responsibility to advocate the employment and retention of veterans. There are many great organizations that recognize the fact that veterans bring unique skills to the workforce, such as excellent technical education and training, and leadership abilities. ### SOUTH DAKOTA AMERICAN LEGION FOUNDATION REPORT

Commander,

Your Foundation was established as a 501(C)(3) non-profit corporation in 2010 for the purpose of accumulating an endowed body of funds that would be professionally invested, with the earning from it to come back to the SD AL to help fund the Legion Programs. Your forward-thinking leadership realized back then, that an income flow from the Foundation would be important to help fund the programs of the SD American Legion. That has proven to be more and more important as time goes by, and will continue to be essential in the future.

The seed money to start the Foundation (approx. \$40,000) came from the SD Honor Flight, when it was dissolved. Since then, the balance has grown from the contributions of individuals, Posts, businesses and events. The annual Fun Auction held at the Department Convention has been an important source of funding. Thank you for participating! Donations of property and collectables as well as cash have been donated. The Foundation being named in individual wills or as the beneficiary of life insurance are terrific ways of helping in the future.

The principal balance of your Foundation will only grow over time. Of the earnings on the invested funds, approximately 4% of the balance is paid back to the SD American Legion. The rest of the earnings go into growth. At the present balance, approximately \$10,000 per year is paid back to the SD American Legion to assist with the many programs within the four pillars of the organization, with emphasis on helping children and veterans.

It has been reported nationally, that giving from businesses and corporations has slowed since the Covid pandemic, but that donations from individuals have been strong. The experiences of your Foundation have been similar, this past year. Individuals have remained strong donors, and Legionnaires are the strongest of the group. Thank you very much!

In the past year, contributions have been just over \$18,000. The Total Net Assets of the Foundation are presently just over \$276,000. The downtrend of the stock market in recent months effects the Foundation's balances. This past year, the

Foundation has granted funds to support the Midwest Honor Flight and the Youth Trooper Academy program.

Thank you for your contributions to the SD American Legion Foundation in the past, and please continue with your support! We are all proud of the work that the SD American Legion does through its many programs. You can be proud of the effects that your contributions to the Foundation are making now, and will continue to make for decades and decades to come. Thank you!

#### INTERNAL AFFAIRS COMMISSION CHAIRMAN REPORT

Fellow Legionnaires,

I would like to thank Commander Wolkow for appointing me to serve as the Chairman for the Internal Affairs Commission for 2022.

The Internal Affairs Commission met on 9 May 2022. Present at this meeting were State Commander Gary Wolkow, State Adjutant Kevin Hempel, Chairman PDC Mark Weinmann, PDC Byron Callies, PDC Terry Hanson, and PDC Tim Jurgens.

The Constitution of the American Legion, Department of South Dakota, provides in Article XV, Section 1, that "Any amendment to this constitution may be proposed by any Post, or by the Department Internal Affairs Commission. Any amendment proposed by a Post shall be submitted in writing to Department Headquarters at least six weeks prior to the annual Department Convention. The Department Adjutant shall present it immediately to the Department Internal Affairs Commission. At least 30 days prior to said convention, the Department Internal Affairs Commission shall transmit to all Posts, through Department Headquarters, a

full copy of all amendments submitted by Posts, together with the favorable or unfavorable recommendation of the Internal Affairs Commission thereon, with a brief statement of reasons for such recommendation, and at the same time the Department Internal Affairs Commission shall in like manner, distribute to all Posts, full copy of any proposed amendment originating with the Department Internal Affairs Commission itself.

No amendment shall be in order for consideration at any convention unless it shall have been so submitted or unless one day notice of proposed of a proposed amendment is given and there is then unanimous consent of all delegates to such consideration. If such unanimous is given, the Commander shall immediately and without debate, refer the resolution to the Department Internal Affairs Commission for consideration and recommendation to the proposing. Convention for final action.

The only way the American Legion is able to change and grow is with resolutions submitted by local posts within the Department.

This year, 9 resolutions have been submitted to State Headquarters from local posts, and 2 resolutions have been written by the Department Internal Affairs Commission, of these 11 resolutions, 5 resolutions are being referred to the Resolutions Committee at the State Convention,

#### 2 Resolutions received DO NOT PASS RECOMMEDATIONS.

- Resolution 22-3 to change the election cycles for District Commanders,
- Resolution 22-9, to change the term limits on members of the Department Finance Commission.

#### 4 resolutions received DO PASS RECOMMENDATIONS.

- Resolution 22-2 would change the elected term of County Commanders to 2 years to coincide with the term of the District Commander.
- Resolution 22-6 would allow posts in good standing with less than 15 members to have 1 delegate and 1 alternate to a vote at the State Convention.
- Resolution 22-10 would change the selection process and term limits on the Department Finance Commission.
- Resolution 22-11 would create separate committees for Membership committee and Marketing, Media and Communications committee.

Annual reports are welcome from the Sons of the American Legion and The Legion Riders; however no reports have been received at this time

The year 2020 took a heavy toll on all forms of public gatherings. The American Legion Riders of South Dakota was no exception. However, 2021 was a year of recovery. Motorcycles were back on the road attending rallies, leading funeral processions and raising funds for Veterans and their families statewide.

One of the earliest events in 2021 was the May "River Wreath Run" with over 20 Riders and family members gathered at Post 8 in Pierre SD. Riders faced snow, sleet, hail and tornadoes on this 2-day event to place a Memorial Wreath on the steps of the Soldiers and Sailors Memorial in Pierre. The group gathered Saturday night for a meet and greet at Post 8. A burger fry with all the fixings was also served there. At 1030 Sunday morning, all gathered on the steps of the Soldiers and Sailors Memorial Hall. A wreath was laid on the steps, the first of many as this has become an annual event for the Riders. The next one is May 22, 2022, at 1030 a.m. As in the 2021 event, Post 8 will host an ala carte reception Saturday night at 6:00. Sunday morning Riders will gather on the steps of the Soldiers and Sailors Memorial to lay a symbolic wreath for all who have perished in service to our country. Another state-wide event was the Commander's 605 Ride in June. Outgoing Commander Fred Nelson (also an American Legion Rider) led a group of 16 Legion Riders out of Post 164, Spearfish SD, on a state- wide circuit of the perimeter of SD. The event took 4 days and covered over 1400 miles. Interstate travel was avoided at all costs. 20 Posts were visited along the way. Each Post provided refreshments and donations to the South Dakota American Legion Foundation. Riders dropped off and/or joined the ride each day. All together over \$4800.00 was raised from the posts visited and another \$1300.00 from the Annual Convention in Huron for a grand total of \$6100.00.

Many other SD ALR Chapters had busy summers as well. The Hot Springs Hoka Hey and Freedom Ride, Spearfish Patriot, Back the Blue and Jacket rides, Custer's Maor Ride, Lemmon's Corn Hole and Hometown Heroes Ride, Wagner's Labor Day and Viet Nam Wall Ride to Parkston, Aberdeen's Teddy Bear and POW/MIA Rides, and Watertown's DTOM Veterans Ranch Run are just a few of the annual events hosted around the state. #### LEGISLATIVE COMMITTEE CHAIRMAN REPORT

Commander,

Here is the annual report of the South Dakota American Legion Legislative Committee. The members of the committee are Chairman Doug Feltman, Chris "Van" Van DeList, Kevin Morello, PDC Rod Martens and PDC Gary Watts. The lobbyists for this year were Doug Feltman, Adjutant Kevin Hemple, PDC Terry Hansen and Chris "Van" Van DeList.

On 13 February a Zoom meeting was held with all committee members attending. Bills that had been submitted were reviewed and the committee was given instructions to review the bills so that an informed decision could be made on each bill at the 22 February meeting in Pierre.

The Council discussed the bills that were likely to be of a concern to Veterans and set the Council's priorities. That evening the Veterans Council hosted a Legislative reception with all Legislators invited and it was well attended by the Veterans Council and Legislators.

On 22 February 2022 the Legislative Committee met in Pierre at Post # 8. Roll called showed the following committee members present: Department Commander Gary Wolkow, Chairman Doug Feltman, Chris "Van" Van DeList and Kevin Morello. Americanism Officer Harry Boner was present as a guest. The Legislative Committee then reviewed and discussed 13 bills, and a decision was made on how we were going to proceed on each bill.

There were 4 House bills that were discussed, and we were going to monitor 3, support and lobby for 1. There were also 9 Senate bills that were discussed, and we were going to monitor 8, support and lobby for 1.

The evening reception was hosted by Post # 8. All Legislators received a written invitation, and it was well attended. This reception gave the Legislative Committee, the Legion Lobbyist, and Legionnaires an opportunity to meet the Legislators, get to know them and give them our recommendations and thoughts on particular bills that had an impact on Veterans. At the reception while talking to the Legislators, it is very obvious that The South Dakota American Legion has a good and respected relationship with the Legislators in the State.

Post # 8 again did an excellent job in hosting the reception and served a delicious supper to all in attendance. Thank you Post #8.

SB 49 - An act to authorize the Department of the Military to construct a cold storage building located in Rapid City, South Dakota to make an appropriation therefor and to declare an emergency - **Signed by the Governor** 

SB 50 - An act to make an appropriation for water, wastewater and storm water projects throughout state government and to declare an emergency - **Signed by the Governor** 

SB 63 - An act to revise the appropriation for road improvements to the State Veterans Cemetery, to provide for ordinary operation of the cemetery, and to declare an emergency - **Signed by the Governor**

## MEMBERSHIP AND MARKETING COMMITTEE CHAIRMAN REPORT

Department Commander Wolkow,

The 2021-2022 year in the South Dakota American Legion was started off from a great year where South Dakota was the #1 Department in membership for the 2021 year. Your Membership and Marketing (M&M) committee's service projects had support from a good number of Posts. Our two service projects for this year were the DTOM 22 Veteran Ranch "sweat equity" day and the Midwest Honor Flight fundraiser. Both events were more successful than we had initially anticipated. Service projects coordinated at the State level are a great way to help organizations who are helping the South Dakota veterans on a daily basis and to increase media coverage of what our Four pillars are.

The DTOM 22 Veteran ranch project on July 10, 2021, had volunteers from across the state coming together to help a South Dakota non-profit. The volunteers from 6 organizations donated over 600 hours of service to include installing 1,000 feet of fence, tore down an old barn, and a significant amount of general cleanup on

the ranch. Local news was there to cover the event and was showcased on the front page of 5 large city publications.

The Midwest Honor flight fundraiser campaign of "Send One" was a huge success. The initial goal was to raise \$50,000 so we could name the flight the "South Dakota American Legion Midwest Honor Flight". The South Dakota American Legion Foundation donated the initial funds of \$10,000 to encourage donations from the Posts. Post 88 of White, SD came to 2021 State convention with over \$6,000 as well to solidify a solid start to this Fundraiser. As of May 1, 2022, over \$180,000 has been raised, this enough money to cover two flights of veterans. This gives our leadership this next year to utilize the media to broadcast the South Dakota American Legion story of community service. This campaign is a huge success for the South Dakota American Legion Family.

The M&M committee this past year created a recruiting brochure specific to the South Dakota American Legion using the consolidated post reports from the past 5 years to show impact. They also created 3 sets of recruiting displays. The displays

were paired with folding tables, tablecloths, a wheeled case full of brochures and a SDAL themed runner. The 3 sets of recruiting materials were given to the 2 Dept. Vice Commanders and the membership chairman to be available for loaning out to Posts for larger recruiting events. This provides a professional looking recruiting table that can help Posts have a standard display to recruit from.

Membership totals for this year were slower than the previous year. As of May 1, 2022, we are at 92.03% of our membership goal. With a historic year of inflation from varying circumstances, many have reported that they were impacted from the inflation.

#### PUBLIC SAFETY COMMITTEE REPORT

The South Dakota Public Safety Committee is tasked with promoting and selecting the" Law Officer of the Year" and the "Firefighter of the Year" programs. We also serve as a liaison for the SD American Legion to the SD Youth Trooper Program.

In July we worked with the South Dakota Highway Patrol during our nineth week-long SDYTA in Pierre. Twenty-four outstanding young people spent the week learning what it takes to be a Law Enforcement Officer. Several of these young people are also enlisting into the military. I know personally, that three of last year's graduates are now Marines plus several others are members of the National Guard and other branches. We can all be very proud of our Youth Trooper Graduates.

We recently learned that there are 25 or more Law Enforcement Officers across the state that are graduates of the first eight academies. Those who attended the last two academies are not yet old enough to get certified. The success of this program is very rewarding to everyone involved.

SDHP Colonel, Rick Miller wrote "Our partnership with the American Legion has phenomenal program for youth in our state that are interested in law Enforcement. This last Youth Trooper Academy was filled with so many energetic, determined and team-oriented kids. On behalf of the SD Highway Patrol, I want to thank you and the rest of the American Legion of South Dakota for their continuing support in Law Enforcement. We look forward to many more years of working together!"

On Thursday of that week, we were happy to see many Legionnaires visit us at the firing range for "Blue Cap Day". That evening we sponsored a cookout for the recruits, mentors and visiting legionnaires.

During the graduation ceremony on Friday, Commander Wolkow, after a few remarks, presented Wyatt Anderson from Willow Lake as the recipient of the "American Legion Outstanding Leadership" scholarship.

The District Commanders or their representatives have done a great job of getting our YTA applicants interviewed. The SDHP and our Committee will again select twenty-four outstanding recruits and alternates to attend the SDYTA on April 22. There selections are made based on their interview scores and recommendations of the SDHP and our committee.

On January 11<sup>th</sup>, 2022, our committee met to select the Law Enforcement Officer of the Year and the Firefighter of the Year. We are pleased that we saw an increase in the number of applications for both of these awards. We thank the posts that took the time to recognize the great work that these first responders do for our communities. Every community has someone who deserves recognition for their service. We encourage much better participation in the future.

Our committee selected Garret Masten from Rapid City as the Law Officer of the Year. We recently learned that Officer Masten has been selected as the National Regional Law Officer of the Year. We will learn before National convention if he receives the National Law Officer Award. Congratulations to Officer Masten and we hope to see you at the National Convention.

We also selected Cody Linneweber, from Garretson, as our Firefighter of The Year. Cody has a great resume. As of this writing, we have not heard from National as to the disposition of his application.

During our January meeting, we visited about the National Guidelines for the Firefighter of the Year Award. The award may be presented to a Firefighter who is



also an EMT. We decided to develop a resolution to present at the Department level to separate the awards and ask National to develop an Award for EMT's and Paramedics separate from the Firefighter Award.

Within South Dakota, probably the longest continued American Legion Post sponsorship of a Troop goes to Spearfish Post 164. They have sponsored Boy Scout Troop 17 for 93 years.

Contact your local Troop or Pack and have your Post check into sponsoring possibilities. Explore opportunities to help make a positive impact. Perhaps Post members could serve as merit badge counselors? Help provide transportation to an outing. If it weren't for an American Legion member that stepped forward, I likely would not have received Eagle Scout.

Each year, the Department of South Dakota awards one Eagle Scout of the Year, and this year's Eagle Scout of the Year is Riley A. Murphy from Summerset, SD. The Troop's sponsor is American Legion Post 320 in Rapid City, SD.

This year for the Sons of the American Legion – Detachment of SD has been nothing shy of amazing. Our leadership team hit the ground running and we haven't looked back yet. We started the year off working in the Veterans Building at the State Fair, informing people about the SAL and recruiting new members.

Then, it was on to the National Convention in Phoenix, Ar. There, South Dakota was well represented and received four national awards. When we returned from National, we went right into the District Fall Meetings. We had an officer at every fall meeting, which is great exposure and representation for the SAL. We also had a representative at all Spring meetings too.

at the end of February for the 3 wreath laying ceremonies and being the guest speaker at Menno's Memorial Day program.

We sit at 125% membership rate (it's actually higher because we still have some transmittals processing yet). This past year has shown a market correction in all sectors of the trust fund. The fund has averaged a negative 7.48% annual yield. The year-end market value as of April 30, 2021, was \$704,856, compared to a year end market value on April 30, 2022, of \$652,075.

The current asset allocation for the trust is as follows:



Cash Alternatives is 1.91% which currently yields 0.17%; Fixed Income 44.05% with a current yield of 2.83%; Equities is 52.01% with a current yield of 1.36%; Real Assets is 2.03% with a current yield of 8.24%,

The committee was not able to meet this year. We were not able to get the information from Wells Fargo on a timely basis to hold a meeting. The market is in a very volatile state at this time, and we will continue to monitor the fund as needed.
