The South Dakota American Legion Foundation met in the Wheeler Room at 3:00 p.m.

A joint Convention, American Legion/American Legion Auxiliary, memorial service was held in the Howe/Glass room of the Arrowwood Conference Center, at 4:30 p.m. The American Legion/American Legion Auxiliary/Sons of The American Legion Joint Banquet was held at 7:00 p.m. on Friday, June 9, 2023, in the Hale and Oacoma Rooms at the Arrowwood Conference Center, Oacoma, South Dakota with Glen Wahus, National Vice Commander, Midwest Region, as the guest speaker.

The 104th Annual Convention of The American Legion Department of South Dakota was called to order at 9:00 a.m., Saturday, June 10th, 2023, at the Arrowwood Conference Center, Oacoma, South Dakota, by Department Commander Doug Feltman of Chamberlain, SD, after a mini concert by the State American Legion Band.

The Colors were advanced and posted by the Color Guard. The National Anthem was played. Department Commander Doug Feltman led the delegates in the Pledge of Allegiance. The invocation was given by Department Chaplain Tom Henley, after which Department Adjutant Kevin Hempel conducted the POW/MIA ceremony. Department Commander Feltman led the delegates in reciting the Preamble to the Constitution of The American Legion in unison.

The Call for Convention was read by Department Adjutant Kevin Hempel.

# OFFICIAL CALL FOR THE ONE-HUNDRED-FOURTH ANNUAL CONVENTION OF THE AMERICAN LEGION DEPARTMENT OF SOUTH DAKOTA

The ONE-HUNDRED-FOURTH ANNUAL CONVENTION of The American Legion Department of South Dakota is hereby called, and in conformity with action taken at the One-Hundredth Convention, will be held in Oacoma, South Dakota, June 8, 9, 10, and 11, 2023.

### **PURPOSE**

The Convention is called to elect officers for the ensuing year and delegates to the 104th National Convention of The American Legion, to consider any proposed amendments to the Constitution and to transact such other business as may be brought before it.

### REPRESENTATION

Representation at the convention will be by Posts. In accordance with the provisions of the Constitution, each Post is entitled to two delegates and two alternates plus one additional delegate and alternate for each fifty or major fraction thereof, memberships shown on the books of the State Adjutant fifteen days prior to the convention, or this year on May 24<sup>th</sup>, 2023. The Constitution requires that the delegates to the Department Convention be chosen by each Post by election from its own membership. Alternates will have power to vote only in the absence of the regular delegates.

Forms for listing the Department Convention Delegates and Alternates are sent to Post Adjutants. These forms need to be signed by the officers of the Post and mailed to reach State Headquarters, PO Box 67, Watertown, SD 57201 by May 24th, or turned in at the Department Convention Registration desk in Oacoma. Note that the 2023 membership identification number of each Delegate and Alternate is required.

In accordance with the Department of South Dakota Constitution and Bylaws, Article IX, Section 3: Every Legionnaire attending the Department Convention shall register and pay a registration fee of \$1.00 and upon proper identification as a Legionnaire in good standing shall receive a Convention badge and be entitled to the privileges of the Convention. The Legion Post hosting the Department Convention shall retain this \$1.00 fee to help defray expenses incurred in holding the Convention. The registration fee for each Post's delegate strength, regardless of attendance, shall be \$7.00 per delegate payable to The American Legion Department of South Dakota, in advance of the election at the annual Department Convention. Department Headquarters shall retain \$2.00 of each delegate registration fee and forward the remaining \$5.00 to the Department Convention host Post to help defray Convention costs.

### DEPARTMENT EXECUTIVE COMMITTEE

A pre-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Arrowwood Conference Center, Oacoma, Thursday, June 8th, 2023, at 1:00 p.m.

A post-convention meeting of the Department Executive Committee, as constituted, is hereby called and will be held in the Arrowwood Conference Center, immediately following the adjournment of the 104th Annual Department Convention of The American Legion Department of South Dakota.

### POST/DISTRICT OFFICIALS

Post and District Officials, unless elected as Delegates or Alternates to the Department Convention, have no privileges in the Convention except as guests of their respective Posts and Districts.

### **CAUCUSES**

Area Caucuses, for selection of State Vice Commander nominees, will be held in assigned areas, Saturday afternoon, June 10, 2023, immediately following completion of that day's convention business session.

### **CONVENTION COMMITTEES**

In accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, convention committees are to be convened for the purpose of compiling policy forming reports to the General Session of the Convention.

Each District shall designate Delegates or Alternates for service on each convention committee and shall file with the Department Adjutant a list of such designees at least two weeks prior to the convening date of the meetings of said convention committees. The convention committees consist of the following:

Employment — 1 Delegate per District

Internal Organization — 1 Delegate per District

Legislative — 1 Delegate per District

National Security — 1 Delegate per District

Rules — 1 Delegate per District

The Department Commander will appoint Legionnaires, with membership in good standing, as the Chairperson and Liaison to each of the convention committees.

All convention committees will meet on Friday, June 9th, 2023, at 1:30 p.m. at the Arrowwood Conference Center, Oacoma, SD, in rooms designated for that purpose. The directory of meeting rooms will be available upon entry into the Arrowwood

Conference Center, on the day of the meetings and also in the Convention Program Book.

The Convention Resolutions Committee will hold its initial meeting, for the purpose of reviewing all convention resolutions to determine the distribution of said resolutions to the other convention committees, on Friday, June 9th, 2023, at 10:00 a.m., in the Arrowwood Conference Center, Oacoma, SD. Room assignments will be announced in the Convention Program Book and will be posted in the convention facility.

Each convention committee chairperson will be responsible for compiling a final report of the actions of their respective committee to the Department Adjutant after their committee has adjourned and prior to the scheduled report of the convention committee to the convention body.

### RESOLUTIONS

Resolutions emanating from a Post shall be forwarded to the Department Adjutant to be in his hands no less than two days prior to the opening session of the Department Convention.

Resolutions which call for an amendment to the Constitution of The American Legion Department of South Dakota must be submitted to the Department Adjutant in the proper form by April 29<sup>th</sup>, 2023. This will ensure that the Department Internal Affairs Commission can screen them in time to allow for the commission's recommendations for approval or disapproval and for the Department Adjutant to distribute copies of these resolutions to all Posts within the Department at least 30 days prior to the convening of the Department Convention.

### **ELECTIONS**

The election of all Department Officers as well as Delegates and Alternates to the 104th National Convention of The American Legion, shall be a Special Order of Business of the Convention and in accordance with the Uniform Code of Procedures for the Organization of Department Conventions of The American Legion Department of South Dakota, will be conducted at 12 O'clock noon on Sunday, June 11th, 2023, or at the conclusion of all other business of the Department Convention, whichever occurs first.

Commander Feltman read a letter of Welcome from the Oacoma Town Board President, Gary Dominiack, in his absence.

Convention host, Post #3 Commander, Ken Anderson, delivered his greetings and welcomed the assembled delegates to Oacoma.

The meeting of the Convention Americanism Committee was called to order by Chairman Tom Henley of Aurora on Friday, June 9, 2023, at 1:30 p.m., at Cedar Shores Resort and Convention Center in Oacoma, SD.

Present besides Chairman Henley of Aurora were the following: District 1 – Jerry Lolley of Sturgis Post 33; District 2 –Doug Harris of Rapid City Post 22; District 3 – Larry Madsen of Gettysburg Post 135; District 4 – Dale Strom of Aberdeen Post 24; District 5 – Chairman Tom Henley of Aurora Post 230; District 6 – Paul Hanson of DeSmet Post 138; District 7 – Pat Mullen of Madison Post 25; and District 8 – Jim Hornstra of Springfield Post 323.

Chairman Henley led the Pledge of Allegiance and read the duties of the Convention Americanism Committee in the Uniform Code of Procedures.

Doug Harris of Rapid City was appointed as secretary.

The Convention Americanism Committee reviewed a total of one Resolution:

### Convention Resolution No. 23-2 was drafted by Redfield Post 92.

Chairman Henley spoke in support of this resolution. Larry Price gave a quick update on the status of this Resolution at the National Level – it is still under consideration. Therefore, we would like to pass it at the Department Level.

RESOLVED, that at the February 2023 regular meeting of the Clay Kiser Post 92, Redfield, SD, our membership urges The American Legion Department of South Dakota to establish a state EMT of the Year award; and be it finally

RESOLVED, that like the Law and Firefighter of the Year awards, post across the state be encouraged to participate in the EMT of the Year award and the Department winner be recognized at the Department convention or an appropriate American Legion function.

A motion to send forward with a Do Pass was made by Pat Mullen, seconded by Paul Hanson. Motion carried.

District 3 representative Larry Madsen spoke about Boys State. He encouraged those present to speak at the Post and District levels in favor of the program. He also mentioned the different scholarships that are available to those individuals who do attend. Discussion was held. There were complaints about the on-line registration process and that the Post doesn't know the boys are interested. Larry pointed out that this was open to the home-schooled boys as well.

Madsen also spoke on the Oratorical contest and the scholarships that are available. 20% of the participants at the National Level are homeschooled. 20% are first generation citizens. He mentioned that the Department is putting together a subcommittee to consider the possibility of changing the day of the Department competition and asked for input from the attendees. At one point the contest was not part of Midwinter and was held separately. This coming year, Midwinter is from Feb 16-18, 2024. The contest would be on Sunday, February 18th.

Larry Price spoke on Youth Trooper Academy. He reported that the program was only about a week and a half away. So far there have been no cancellations. Lt. Maunu, the HP POC for several years is retiring and the new POC is in the middle of being trained. The number of applicants this year was 40. Thursday June 29th is "blue cap" day with the 30<sup>th</sup> being graduation. The cost for YTA will be the same as Boys State in 2024 - \$250. We now have 30 YTA graduates who are either in law enforcement and/or the military.

Air Rifle was addressed by Mike Kraft, Britton Post 80. A recent competition in Pierre drew over 3,000 competitors. Posts were encouraged to put together teams and talk about the competitions/scholarships available.

A motion to adjourn at 2:22 was made by Jerry Lolley and seconded by Pat Mullen. Motion carried.

Post Americanism Award for 75-124 goal-size group awarded to Frank J. Brune Post #140 of Salem, SD.

**Post Americanism Award for 125-350 goal-size group awarded to** Spearfish, Inc. American Legion Post #164 of Spearfish, SD.

Post Americanism Award for 351 and larger goal-size group awarded to Rapid City American Legion Post #22 of Rapid City, SD.

#### NATIONAL EXECUTIVE COMMITTEEMAN REPORT

From the NEC:

The year is really going fast and I'm enjoying being your National Executive Committeeman. At the Spring District Meetings this year, I've been



discussing the issues that The American Legion has put forth as their priorities for the upcoming year. At the American Legion Legislative Conference in Washington D.C., we discussed the issues and Legionnaires from all over the country went to Capitol Hill Tuesday and discussed these issues with their congressional delegation. Wednesday morning, I had the honor of attending the National Commander's testimony before the joint Senate and House Veterans Affairs Committee. The

National Commander did an excellent job representing The American Legion. The legislative priorities for the upcoming year are Mental Health & Suicide Prevention, VA Healthcare Modernization, Implementation and Oversight of the Pact Act, Protect Veterans from Predatory Actors, Concurrent Receipt, Guard and Reserve GI Bill Parity, GI Bill for Honorable Service, support our Afghan Allies, Military Quality of Life, Pay the Coast Guard and Protect the American Flag.

The National Commander's program this year is the Veterans & Children Foundation. This foundation is used to fund the training for over 3,000 American Legion Service Officers. The American Legion service officers secured an estimated \$14.25 billion in disability compensation and other benefits to veterans in 2020 alone. Also, funds are used for the temporary financial assistance program for veterans that are in need that have minor children at home. Funds from this fund have come into South Dakota to help veterans in our state who really needed help. The goal for South Dakota is \$30,728.26. To build this endowed fund up, all departments were asked to give 25 cents a year per member for six years or \$1.50. We have a little over 2 years left to make our goal and presently we are a little over halfway there. Please, if your Post is able, give a dollar per member to this fund. Send your Post donation to State Headquarters, National Headquarters, or the National Commander when he comes into the state.

Don't forget the Buddy Check Program. "Be the One" to prevent a veteran from committing suicide. I would like to close by saying thank you and your post for all you do for the American Legion. No matter how big or small, any thing you do makes a difference.

#### DEPARTMENT SERVICE OFFICER REPORT

Mr. Commander,

I would like to thank Commander Doug Feltman for appointing me to serve as Department Service Officer for 2022-2023.

As Department Service Officer, I have the unique privilege of directly serving Veterans and their families in helping them obtain and utilize the benefits they have earned through service to our country. The VA is undoubtedly its own mountain to climb, and I am happy to be a guide of sorts.



It has been a big year for benefits in the VA world. In August 2022 the PACT Act was passed, a sweeping piece of legislation that covers multiple generations of Veterans. For Gulf War-era and Post 9/11 Veterans who served in the Middle East or the airspace above, the following cancers and illnesses are now presumptive: Brain cancer, Gastrointestinal cancer of any type, Glioblastoma, Head cancer of any type, Kidney cancer, Lymphatic cancer of any type, Lymphoma of any type, Melanoma, Neck cancer of any type, Pancreatic cancer, Reproductive cancer of any type, Respiratory (breathing-related) cancer of any type, Asthma that was diagnosed after service, Chronic bronchitis, Chronic obstructive pulmonary disease (COPD), Chronic rhinitis, Chronic sinusitis, Constrictive bronchiolitis or obliterative bronchiolitis, Emphysema, Granulomatous disease, Interstitial lung disease (ILD), Pleuritis, Pulmonary fibrosis, and Sarcoidosis.

For Vietnam Veterans, the presumptive list for Agent Orange exposure now includes MGUS (blood disease) and Hypertension. Additionally, the PACT Act expanded the presumptive locations to include Any U.S. or Royal Thai military base in Thailand from January 9, 1962, through June 30, 1976; Laos from December 1, 1965, through September 30, 1969; Cambodia at Mimot or Krek, Kampong Cham

Province from April 16, 1969, through April 30, 1969; Guam or American Samoa or in the territorial waters off of Guam or American Samoa from January 9, 1962, through July 30, 1980; and Johnston Atoll or on a ship that called at Johnston Atoll 1972. through September 1.

On January 17, 2023, funding starting for the COMPACT Act, a bill that passed in 2020 that allows Veterans in suicidal crisis to go to any health care facility, at VA or in the community, for free emergency health care regardless of their enrollment in the VA system. This is a huge benefit and will help in our fight against Veteran Suicide.

I am thrilled to report that State, County and Tribal Veterans Service Officers around South Dakota utilizing the American Legion Power of Attorney have secured \$42,545,265 in VA benefits for South Dakota Veterans and their families in Fiscal Year 2022. If you have not thanked your local Veterans Service Officer lately, please do so!

My report begins with the start of the 2023 baseball season. Jan 1st begins the start of a new baseball season with all teams completing registration by May 15th. Hopefully we will have another successful season as we did last year with a record number of teams being registered in 2022.

Tournament sites for 2023 are as follows: State A Sr Tournament to be held in Yankton from July 25<sup>th</sup> thru July 29<sup>th</sup>; St B Sr Tournament to be held in Redfield from July 28<sup>th</sup> thru Aug 1<sup>st</sup>; St A Jr Tournament to be held in Harrisburg from July



27<sup>th</sup> thru July 30<sup>th</sup> and the St B Jr Tournament to be held in Lennox from Aug 4<sup>th</sup> thru Aug 6<sup>th</sup>. This years' Golf Tournament will be hosted by Hermosa at 2 different locations in the Rapid City area. Everything is all arranged and looks to be on schedule.

On Jan 29<sup>th</sup> of this year, we made selections for the 2024 tournament host sites. They are as follows: St A Sr will be hosted in Mitchell; St B Sr will be hosted in Salem; St A Jr will be hosted in Pierre and the St B Jr will be hosted in Groton. No selection for the Golf tournament yet for next year. If interested in hosting the Golf tournament, please contact Elton Blemaster or Gene Gillen.

Just a note on hosting any of our tournaments. We need our Posts to get involved with our parent groups when hosting any of our tournaments. Last year we had 2 tournament sites that the Posts would not sign contracts for hosting the tournaments. Reasons for not signing were, did not know we were hosting a tournament, worried about insurance liabilities or worried about their financial obligations. To address some of concerns are that when a team purchases their team's insurance a 2 million liability is included with your team's accidental insurance, that should cover any issues that might occur. As far as financial concerns, in my 20 years of running this program a post has never lost a dime, in fact last year one of the Posts not wanting to sign a contract lost out on a percentage of a \$13,000 net gate that the parent group took in and I think would have been willing to share with post at some percentage with a little support. Please get involved or get your Sons of A.L. involved if you have one, if not this would be a great reason to get one started.

What's new for 2023? We were supposedly changing our branding label, which meant new uniform patch or logos. We were supposedly getting new baseball patches for all our uniforms that would have been required by 2024. But that has again changed because of the limited supply of the new patches available. So, for teams purchasing new uniforms this year you will once again be required to use our already existing patch until further notice. I think will solve our current Branding issue until further notice and further research can be completed.

One more thing to bring up is that the SDHSAA is considering sanctioning baseball as a High School sport. As of now nothing has been confirmed yet, but it is coming. My only concern is that we don't want them to extend that season into June. That would totally ruin our season and program. Currently their tournaments end on Memorial Day weekend which works great with our program, and I do support. For years they have done it that way and it has been working just fine. I think they are maybe pushing for a bit longer season as I also would have liked to start our season in May instead of June like we currently do. I am scheduled to meet with the SDHSAA after the Basketball season. Please let your AD know that we support their program, but it cannot go into June for their tournament play. Thank You!

#### CHILDREN AND YOUTH CHAIRPERSON REPORT

Commander Feltman,

The South Dakota American Legion C&Y (Children and Youth) program this past year was a quiet one but a rewarding one. Thank you for selecting me as the Children and Youth Chairman for the Department of South Dakota. Your leadership and willingness to direct my efforts for the year were greatly appreciated.

In the past several years, the C&Y program within SD has worked closely with the Dollar Tree Program, in association with Operation Homefront. This last year, the



South Dakota National Guard, took the primary lead on collecting and distributing donations of school supplies for helping those voung Veterans families with children at home. The same process was repeated in early December as the Dollar Tree once again collected donations of small toys for distribution to Veterans families. There were a few Dollar Tree stores that did not have a National Guard Armory associated to it to make the donation pickups so local Legion Posts were able to pick up those donations

and distribute them within their local communities. In December, with the help of the Brookings and Sisseton Posts, I was also able to pick up donations from 2 other Dollar trees, package gifts into 20 gift bags, and deliver them to the VA in Sioux Falls for distribution to Veterans with children. This is a great program that I hope the American Legion will continue to be a part of.

Additionally, Operation Homefront donated backpacks full of school supplies to Air Force personnel with children at Ellsworth AFB. Around 15 Legion, Auxiliary, SAL and Legion Rider members from Districts one and two, on short notice, volunteered to help distribute 340 of these backpacks on July 30th. It was great to see so many step up to help make this event such a success.

Operation Homefront will continue to offer the school supply, backpack, and toy programs in the coming years. On a side note, through my interaction with Operation Homefront with the Backpack distribution and Dollar tree programs, I have been asked to become a member of the Operation Homefront Advisory Council, to represent the State of South Dakota in the upper Midwest region. I hope to continue to work with future C&Y Chairman of the American Legion, Department of South Dakota, on many more collaboration projects together between the two organizations. A program that I wanted to promote this year as the C&Y Chairman was a donation fund raiser with proceeds to be split between the Children's Miracle Network (CMN) of South Dakota and youth programs in the South Dakota American Legion, which includes TFA.

Children's Miracle Network helps South Dakota families with sick or injured children with: Specialized equipment needs for the Sanford Children's Hospital, Child Life Specialists to help teach our children about their illness, Travel assistance, Food Vouchers, and Lodging

Veterans with children at home can file for TFA (Temporary Financial Assistance), in times of need to help cover some the immediate needs of the Veterans family. Veterans can apply for assistance through their local American Legion Post. Early in the year, there was a request to use the TFA program, however at the time, the criteria for using the program were not met because of the situation at the time. Unknow to me, there was an update to eligibility for TFA in the past year that could have been explored.

The American Legion passed Resolution No. 5 (May 2022) Titled: Policy and Procedures of the Temporary Financial Assistance Grant Program. The policy clearly states that the minor child must be living full-time in the home of a qualifying veteran or service member. The minor child qualifies if they fall into one of the below categories. Yes, the veteran (grandparent) could qualify for TFA if the minor child(ren) is living in the veteran's home full-time and is under the veteran's legal

guardianship or has been adopted by the veteran. The child is: a biological child of the veteran or service member, a child legally adopted by the veteran or service member, a stepchild by marriage of the veteran or service member, a child who is under the legal guardian ship of a veteran or service member. I have attached a link to the resolution here. <a href="https://archive.legion.org/node/7887">https://archive.legion.org/node/7887</a>.

Posts, Units, SAL or Rider groups that have or are still collecting funds for the Children Miracle Network/State Youth Activity fund, please memo your check as CMN/C&Y and either mail them to state HQ or present them at the State Convention this year. Once a total of donations is determined a check will be presented to CMN of SD later this summer.

Again, I wanted to thank you for selecting me as your state C&Y Chairman for the 2022-2023 Legion year. It has been a great year working with you. Thank you for your direction and mentorship. I wish you all the best in the coming years!!

The education scholarships offered by the Department of South Dakota are for children of veterans, grandchildren of veterans, and veterans who meet the requirements as set forth in the Education Scholarship brochure attending postsecondary education, college, or technical schools. Please read the brochure for all the current changes. In all cases, the veteran listed on the application must be a member of the South Dakota The American Legion. The student must attend a higher education school in the state of South Dakota unless their plan of study is not taught in a South Dakota school. The fund is self-sustaining through donations.

Annually, the brochure and application processes are reviewed. No monies were added to the fund from the Department's outside income programs. More specific details can be obtained from State Headquarters, your District Education Loan Chairperson, or a member of the state Education Scholarship Committee. The state committee consists of Michael Pauling, Piedmont, Philip Egeberg, Brookings, and Hugh Holmes, Mitchell.

# SOUTH DAKOTA AMERICAN LEGION FOUNDATION REPORT

Commander,

Your South Dakota American Legion Foundation began in 2010, because of the foresight of our leaders at the time, in believing that it is important to have a steady source of revenue to help support the many valuable programs of the American Legion. It is structured as a 501(C)(3) non-profit corporation, so that the donations to it can be tax deductible for the donor. The funds are professionally managed by



the South Dakota Community Foundation. As they accumulate, the donations to the Foundation go into an endowed fund that is invested. It is the return on these investments that becomes available to the SD American Legion to support the programs. In this way, the endowed fund itself is not depleted, and the returns on the investments will continue forever.

The Foundation works! The present balance is approximately \$275,000. Approximately \$10,000 per year is available back to the Legion for its programs. In recent years,

Grants have been made to the following: The SD American Legion's Children and Youth program; SD Boys State; Midwest Honor Flight; The SD American Legion's Youth Trooper Academy program; and The National Veterans and Children's Fund. At the present time, funds are available for more granting.

Donations can be in many forms such as: outright gifts of cash or property; bequests through your estate by naming the SD AL Foundation in your will; memorials in memory of friends and fellow veterans and Legion members who have passed on so that their legacy will continue to live forever; naming the SD AL Foundation as the beneficiary of a life insurance policy so it will pay out upon your death; as an IRS approved "IRA Charitable Rollover Gift" so that your distribution is paid directly to the Foundation, rather than become taxable income to you. All of these gifts help assure that the American Legion programs that you care about will continue to be supported forever. Gifts of \$10,000 or more by an individual, entitle the donor to name the specific Legion program that he/she wishes to support. Please let the Foundation know if you would like assistance in structuring a donation.

Thank you to all of the individuals, Legion Posts, veterans' organizations (within and outside of the Legion Family) and businesses who have made donations to the Foundation! Many Posts and individuals regularly give memorials to honor friends, fellow veterans and Legion members who have passed on. If your Post is one of those, thank you very much! If not, please consider it as a way to ensure that their legacy will continue to live on forever. Many Posts have made significant donations to the Foundation. Thank you very much! If it has been some time since your Post has donated to the Foundation, please discuss the possibility of a donation to the Foundation with your membership. Your contribution will assist the S.D. American Legion forever. Thank you for your consideration!

We also want to thank you for your participation in Foundation fund raising activities. Over the years we have had several raffles that have been well supported and important income sources. Thank you for purchasing tickets, and congratulations to the winners! Following the Department Convention, we plan to kick off a new raffle that we feel will have prizes of broad interest to all, at a modest ticket price. More details to come. Another important fund raiser has been the Fun Auction held at the Department Convention each June. We thank those who donate the items, and those who bid on and purchase the items. Thank you to all! It really is a fun event, with quality items offered for sale! Thank you for donating the quality items, for without them, this event would not happen. Please plan to join in the fun coming up in June!

The Foundation Board members serve staggered terms at the appointment of the Department Commander. Thank you, Mr. Commander, for the privilege to serve!

# INTERNAL AFFAIRS COMMISSION CHAIRMAN REPORT

As this year's Chairman of the Internal Affairs (IA) Commission, I would, first of all, like to thank Commander Feltman for appointing me. The Internal Affairs Commission is very instrumental in guiding the internal operation of the SD American Legion. In addition, the Commission has purview of the Sons of the American Legion and the American Legion Riders. Members include Chairman Callies, along with members PDC Hanson, PDC Jurgens, and PDC Weinmann, along with ad hoc members Adjutant Hempel and Judge

The IA Commission met via Zoom on May 4, 2023, at 1900 hours, with all members present. Guests included Alternate NEC Nelson representing the American Legion Riders and Casey Hanson, representing the Sons of the American Legion. Commander Feltman thanked the members of the Commission for being active members and for participating in the Zoom meeting. Chairman Callies informed the group that there is no written job description for the Commission and he and the Adjutant will be working together to propose a job description.

SAL Commander Hanson gave a short report on the SAL. He is very happy as to the events of the year and reported that there are 41 active squadrons in the Department and has a membership of 1,534, 112% of the Department's goal.

Alternate NEC Nelson gave a very informative report on the American Legion Riders and their activities in the State. He reported that there are normally two meetings of the ALR during the year, one at midwinter and one at Department Convention. This year, rather than at the convention, the Riders will hold their meeting in Pierre the weekend before Memorial Day. This is in conjunction with the Third Annual Wreath Laying Ceremony at the Soldiers and Sailors War Monument.

Four resolutions were submitted as follows: 23-1, a resolution defining as to how the Legionnaire of the Year should be selected, and was voted to send it back to the post for further revision; 23-2 regarded implementing an EMT award in addition other awards and was voted to send to Finance Committee for review; 23-3 and 23-4 both concerned Veterans and how some benefits were defined and that SD support legislation to revise some issues in Title 38 of the Code of Federal Regulations, both were sent to the VA&R Convention Committee.

There were no resolutions concerning the changing of the Constitution and By-Laws.

#### LEGION RIDERS REPORT

Commander Feltman.

Serving as the Department Commander's "American Legion Riders Liaison" has been an honor this past year. The American Legion Riders are one of the most visible and popular programs of the American Legion. The chapters of the American Legion Riders' strength come from their efforts at the post level, where its members manage the chapters. The uniqueness of this program resides in its membership, which includes Legionnaires, Auxiliary, and Sons of the American Legion.



The American Legion Riders guide their activities around the American Legion Four Pillars: Veterans Affairs and Rehabilitation; National Security, Americanism, and Children & Youth.

Chapters support the first pillar, **Veterans Affairs and Rehabilitation**. The Chapters provide final respects to Veterans with escorts and flag lines at funeral homes, churches, and cemeteries, many at the Black Hills National Cemetery. Chapters reported participating in homecoming parades, parades of lights, Fourth of July, and city parades. Four times a year at the Black Hills National Cemetery, American Legion Riders join other veteran organizations and supporters in helping to provide unaccompanied veterans an honorable service.

Chapters supported veterans in VA facilities through programs such as Christmas in July, National Salute to Veterans Week, Veterans' Day, the Four Chaplains Memorial Service, Valentine's Day, Christmas Gift Shop, parties, bingo, and ice cream socials, to name a few.

Chapters support Veterans in the community by conducting Veterans Day programs, a poker run for Suicide Awareness, socials and picnics, decorating veterans' graves for Memorial Day, placing Holiday Remembrance Wreaths and helping with Wreath Across America at the Black Hills National Cemetery and State Veterans Cemetery in Sioux Falls. The Riders also help preparing the "Avenue of Flags" at the Black Hills National Cemetery. In addition, they lead the Black Hills State University Jacket Ride that raises funds for veterans' scholarships.

To support the second pillar, **National Security**, one of the main focuses is to promote full accountability of the POW/MIAs through community and youth awareness. The chapters reported performing several POW/MIA Ceremonies of Remembrance at conventions, dinners, and schools. Riders also support the troops by providing escorts, flag lines, and sending care packages. Riders assisted with the "We've Got Your Six Veterans Appreciation Fair" in the Northern Black Hills. This year, the Black Hills Riders Chapter #164 planned and held the Colonel Mike Kain Memorial Blood Drive which surpassed its goal.

**Americanism** is the third pillar. Two main events and programs highlight the impact of the riders. The first step is to educate our youth, resulting in Flag Protection awareness. An annual flag etiquette program by Black Hills Chapter #164 touched 180 first graders in Spearfish; 140 kindergarteners in Belle Fourche, and 30

preschoolers in Sturgis. All chapters reported, planned, and organized poker runs to raise funds for the signature program of the American Legion Riders.

As for the fourth pillar, Children & Youth, the American Legion Riders are known in many communities for their volunteerism and service. Some of the most common and regular activities are fish fries, bingo, color guards at community functions, and visiting veterans in hospitals and residential facilities. community-based projects are annual events such as sponsoring bands in the park free of charge to the public, participating in community chili cook-offs to support adults with disabilities, and posting colors at the Relay for Life event. Rapid City Chapter #22 adopted a first-grade classroom in Sturgis and conducted monthly activities with the students. Rieck-Morgan Warner Chapter #137 holds a Teddy Bear Ride to collect plush bears to distribute to children while going to hospitals in the Aberdeen area. The Ft. Pierre Chapter #20 held their first fundraiser to support Sleep Heavenly Peace to build beds.

The Riders come together to support their community, the veterans, and military service members, sharing a common love of motorcycles. The American Legion Riders is growing in membership and chapters; this past year, Ft. Pierre Post 20 started a Chapter, bringing our total to 13 chapters.

There are two statewide Riders' meeting. One take place during the Midwinter Conference and the second one usually during the State Convention. To allow to bring the Chapters together and provide a time to ride, this year the Statewide Riders meeting will be held in Pierre the weekend before Memorial Day in conjunction with the Third Annual Wreath Laying Ceremony at the Soldiers and Sailors War Monument.

In conclusion, I would like to thank all South Dakota American Legion Riders members for their dedication and hard work in serving their communities and advocating for veterans. We are looking forward to another successful year ahead.

#### LEGISLATIVE COMMITTEE CHAIRMAN REPORT



It was an honor to serve as Chairman of The American Legion Department of South Dakota Legislative Committee for the 2023 legislative session. The members of the committee are Chairman C.P. Van Delist, Kevin Morello, PDC Rod Martens, Dan Fritz and Mike Mehlhaff. The lobbyists for this year were C.P. Van Delist, Adjutant Kevin Hempel, and Mike Mehlhaff.

On January 24,2023, the committee held a Zoom meeting to review bills and discuss those of concern to The American Legion Department of South Dakota. The priorities

were set, and the committee agreed on which bills we were going to watch, lobby for and lobby against.

The Legislative Committee met in person on February 7, 2023, at Post 8 to review the session up to that time and adjust priorities as necessary. Roll call showed the following committee members present: Department Commander Doug Feltman, Department Adjutant Kevin Hempel, Chairman C.P. Van Delist Mike Mehlhaff and Kevin Morello. That evening Post 8 hosted a Legislative reception with all Legislators invited. This reception gave all in attendance an opportunity to discuss legislative items and issues that impact on Veterans. Special thank you to Post 8, as always, they were an amazing host.

The membership table, banners and materials were used at many places around the state. The Sturgis Motorcycle Rally and the I Got Your 6 event which is open to all veterans. The South Dakota State Fair, the Brown County Fair and Irene's first ever Christmas Fair. I know the other two sets were also used at other events to help get the word out.

We have encouraged all post to call, text, write or make personal visits to those members who have not renewed and explain what The American Legion does for all veterans.

At this writing we are at 90.97% and need 1,538 new and renewals for the Department to reach 100%. It is achievable but there are some rural post where there are no veterans to recruit to replace those who have reported to Post Everlasting. This was discussed on our last regional zoom meeting with all departments present expressing the same they had the same problems and our national representative telling us this has been discussed for several years with no solution so far.

I also want to thank the Membership Committee, Adjutant Hempel, Judy, Mary Jo and all who have worked hard to achieve that 100% or more goal. The District Commanders have work hard to encourage each Post to all members to be a recruiter because this is their American Legion.

We had 23 outstanding young people attend the weeklong academy held at the Law Enforcement Training Center

Again the South Dakota Highway Patrol did an outstanding job of hosting the event. Ten State Troopers volunteer to be away from their duty stations and families all week to serve as instructors and mentors to our recruits.

Houghton Award, and South Dakota is home to the 2021-2022 National Recruiter of the Year,



just to name a few. To put things in perspective, a detachment averages two awards at the National Convention, and we had 11 last year. To say South Dakota is "on the map" at the national level is an understatement.

Coming back from the National Convention, we worked side by side with our other family organizations at the South Dakota State Fair in the Veterans Building. This proved very fruitful as throughout the week each organization recruited numerous members and answered questions that were brought forth. Then we went into Fall meetings where we had an officer at each meeting. We believe having a strong presence at events creates a caring, important impression for the SAL.

We have chartered 5 new squadrons this past year: Menno, Polo, Rock Creek, Aurora, and Bruce. This along with our current membership and renewal rate will allow us to receive the Triple Nickel Award at the National Convention again this year. Two years in a row for this award is unheard of. We sit at 107% membership rate; our renewal rate is 85%. Our South Dakota detachment and sons across the state do amazing work when it comes to membership.

During the Midwinter Conference held in Huron, at the general business meeting, the delegation voted to endorse Jeff Shannon to put his name in consideration for National Vice Commander. If elected, this term would run in 2 years. At the same time, the delegation unanimously endorsed Casey Hanson to put his name in the ring for National Commander. This would be a minimum of 5 years out if considered and elected, as the next 4 years candidates are already set in motion.

I need to give a big thank you to our SAL leadership, Shane, Dewey, Jeff, Kerry, Wyatt, Doug and the headquarters staff. They have all stepped up when asked for help and are there for anything we ask of them.

Thank You, State Commander Doug Feltman for the appointment to Chairman of the V.A.V.S. Committee this year. It was challenging at times, but in the end we met the goals we set out for.

We have dedicated leaders in our VA Hospital Representatives: Sioux Falls VA Hospital VAVS Representative Larry Panning; Hot Springs VA Medical Center and State Veterans Home VAVS Representative Angela Koch; and our Ft. Meade VA Medical Center VAVS Representative Buck DeWeese. Additionally, I stopped and visited with Sioux Falls VA hospital on site coordinator, Crista Pick, she gave me a tour of the improvements made to storage areas and introduced me to one of the volunteers. We discussed the operation and procedures used by her office and I left with the impression the operation was running quite well.



During our annual VAVS meeting, it was decided that coming out of the COVID restrictions and with rising inflation to raise the amount given to each facility from \$1000 to \$1100. These funds are used for our Veteran's daily needs, for outing activities, and for the annual Halloween & Christmas parties at each center. Each VA medical center has similar needs such as dental and personal hygiene supplies. There is always a need for snacks [beef jerky], popcorn and coffee, shoes, clothing, stamps,

and phone cards. To meet this need it is best that each facility has the cash funds available to purchase what they need.

Knowing that most Posts send in a donation of \$10 for each of our Veterans final service, I encourage that with the recent increase of the funeral stipend from \$50 to \$100 that Posts increase that donation to \$20 or more. Helping support VAVS is just another way The American Legion continues to take care of our Veterans. It is a welcome reminder to our Veterans in Michael J. Fitzmaurice State Veterans Nursing Home and VA Hospitals that "You Are Not Forgotten".

In closing I want to say "Thank You" to all the VAVS. Committee members for their dedicated work for Veterans. "Thank You" to all the Legion Posts, Auxiliaries, Sons of American Legion Squadrons and the American Legion Rider Chapters for your time and monies that go for a great cause, the Veterans! Here's wishing good health and God's Blessing to all of you. Please keep the donations coming and Volunteer whenever you can!


